#### **MINUTES**

#### I. Call to Order

Ms. Busey called the meeting to order at 3:00 p.m.

# II. Approval of Minutes – March 27, 2018

MOTION by Ms. Tea Jones to approve the minutes of the March 27, 2018 meeting; seconded by Mr. McCallister. Upon vote, the Motion Carried Unanimously.

#### III. Vote by Management Members of LMHIC on the Nomination of Barb Mann to Serve as Co-chair

Ms. Busey explained there was an email process to solicit nominations for Co-chair. The Management members nominated Barb Mann. She accepted the nomination.

Upon vote, the Motion Carried Unanimously.

#### IV. 2018 Health Fair Planning and Discussion

Ms. Heiser reported the only companies who agreed to participate are the current Champaign County insurance providers. She suggested the Health Fair be postponed until open enrollment; in an effort to include a larger group of participants.

Ms. Busey encouraged committee members to provide suggestions related to wellness initiatives to Debbie Heiser.

MOTION by Ms. Busey to postpone the 2018 Health Fair from June until open enrollment; seconded by Mr. Clifford. Upon vote, the Motion Carried Unanimously.

# V. Health Insurance Survey Results

Mr. Malachowski reviewed the results of the survey. He noted the return on the survey was larger than anticipated. There were 266 responses, which is approximately a 35 percent response rate.

Mr. Malachowski noted Champaign County has a larger percentage of members who are enrolled in the Blue Access for Members (BAM) site than all of BCBS's other clients. He encouraged committee members to register and to promote registration to others.

According to the survey results, twice as many respondents rated their overall experience as "positive" as opposed to "negative".

The committee would like to distribute the survey again prior to the decision for 2019 Health Plan decision.

# VI. 2017 Claim Review

Mr. Malachowski reviewed the claim information provided by Health Alliance for 2017, as well as the first quarter BCBS claim information. He noted that BCBS is the only provider who will provide an Order of Reduction for pharmacy claims.

Mr. Malachowski reminded the committee to use discretion when talking about claims information with people outside the committee, in order to protect member's privacy.

Mr. Malachowski stated he expects renewal numbers from BCBS by the first week of July.
