The fund balance will not actually go negative, as actual expenditures will be monitored and limited to available resources.

The greater than 10% change in FY2015 is due to a transfer from the General Corporate Fund County Clerk budget to this fund in FY2015 which will then be transferred back to General Corporate Fund in FY2016 – documenting savings from the FY2015 budget that will be utilized for FY2016 expenditure.
