Dear Mr. Reinhart:

Based on the five bids that were received yesterday for the above referenced project, it is our recommendation that this work be awarded to the low bidder Advanced/Wayne Cain & Sons Roofing of Urbana, IL, for the base bid amount of \$243,000.00. A bid tabulation is attached for your review. We have reviewed Advanced's proposal and find it to be in compliance with the contract documents. We have also contacted them and they have indicated that they have a clear understanding of the project scope and will accept a contract for this work, if offered.

A deduct alternate was received to reduce the base bid in the amount of \$8,000 to install pre-finished aluminum valley flashing in lieu of copper flashing. Copper flashing is a higher quality and more durable material and we would recommend not accepting Alternate No. 1. A unit price was also received should additional sheathing be found damaged after the removal of the existing roofing. The unit cost submitted by Advanced was \$3.15/sf. While this price was higher than the other bidders, it is within reasonable costs and we anticipate the damaged areas to be minimal.

After approval of the Champaign County Board, we will proceed with the proper paperwork as directed by you to move this project forward. If you have any questions concerning the bids received, please free to give me a call.

Award of Contract for RFP 2010-006 - EOC - AUDIO VISUAL SYSTEM

In preparation for the County Board Meeting on October 21<sup>st</sup>, please consider the following background information regarding the results of the bid for the EOC Audio Visual System, which is a new system for the Emergency Operations Center to be purchased with a grant award received by the Emergency Management Agency earlier this summer.

The County received six responses to the RFP. Of those responses, two responded with the equipment that had been specified in the County's bid documents, and four responded with the proposal of alternate equipment to the equipment specified by the County. The Bid Analysis Sheet is attached to this Memorandum for your information.

The evaluation team for this project consisted of Bill Keller, EMA Director; Alan Reinhart, Facilities Director; Doug Miller, Technology Specialist for METCAD; Greg Abbott, METCAD Associate Director; and Denny Inman as Consultant for the County Administrator. The evaluation team spent extensive time conducting a thorough review of the bid responses. As a result of that review, the consensus of the team was to focus on the two responses which had specified the equipment requested by the County. This determination was based upon the fact that the specified equipment is considered to be of a higher quality than the alternate equipment that had been proposed, and the specified equipment was attainable within the project budget.

Of the two responses specifying the requested equipment, J. Tandy total bid cost was very slightly less than Zeller's. However, this was not the only basis for the recommendation to award this bid to J. Tandy. In the opinion of the entire evaluation team, J. Tandy had provided the best design documents for this project, and the team had the greatest level of confidence in the J. Tandy proposal as meeting the expectations and requirements for this project.

Based upon the foregoing, the evaluation team recommends to the County Board award of Contract pursuant to RFP 2010-006 – EOC Audio Visual System, to J. Tandy in the amount of \$111,555.66.

The total budget provided for this project under the grant that has been awarded is \$140,149. This recommendation is reflected in Resolution No. 7497 on the County Board Agenda for your meeting on October 21st.
