Property Tax Budget Amendments and Recommendations regarding reserve Fund Balances

Issue #1

In November 2018, the County Board approved its property tax levy to capture new growth revenue allowed under the Property Tax Extension Limitation Law (PTELL), in the event that hospital property Equalized Assessed Value (EAV) was returned to the tax rolls. The County budget was prepared to include additional revenue, and in some funds additional appropriation. A ruling in the hospital property tax exemption case has not yet occurred.

Recommendation:

Budget amendments are recommended to decrease FY2019 revenue by the difference between the amount levied and the amount extended for the property tax levy funds listed below, and to decrease FY2019 expenditure by an equal amount if there was an additional appropriation in the fund.

REQUESTED ACTION

The Champaign County Board approves Budget Amendments 19-00031, 00032, 00033, 00034, 00035, 00036 and 00037 to remove budgeted property tax revenue and related budget expenditure associated with levying to capture new growth revenue in a potential hospital property tax case ruling.

Issue #2

In April 2019, the County Board completed the sale of the Champaign County Nursing Home, and defeased the Nursing Home construction bonds. The County is no longer levying for the Nursing Home Debt Service Fund and the Nursing Home Fund, and the funds will ultimately be closed.

Recommendation:

In anticipation of the eventual closure of these funds, and in consultation with the State's Attorney's Office and the County's outside auditor, staff recommends moving the FY2015 Urbana TIF surplus distribution reserve fund balances, from the Nursing Home Debt Service Fund and the Nursing Home Fund to the General Fund reserve fund balance. The current and recommended reserve fund balances are reflected on the following page.

Issue #3

In tax year 2018, taxes currently being collected in 2019, OSF Healthcare EAV was added to the tax rolls. OSF is expected to defend the exemption on the merits before the Illinois Department of Revenue. OSF has raised procedural claims relating to this exemption in both the Champaign County Circuit Court and the Department of Revenue. This is an uncertain area of the law. Reserving these funds would make it easier to provide a refund should OSF succeed in either forum.

Recommendation:

Staff recommends the County record the property tax revenue received in FY2019 as a result of the OSF Healthcare EAV being added to the tax rolls in 2018 as Reserved Fund Balance, as opposed to unreserved fund balance. This reserve will be in addition to the previously stated reserve fund balances from the FY2015 Urbana TIF surplus distribution.

Non-bargaining Employee Salary and Health Insurance Recommendations for FY2020

ISSUE

In preparation for the FY2020 budget process, County Administration provides a recommendation for non-bargaining employee salary increases and adjustments to the salary schedule, and for health insurance premium plan contributions for the County's non-bargaining employees, excluding those employed by the Regional Planning Commission. The recommendation considers: internal equity and minimizing wage compression, improving employee recruitment & retention, wage and salary schedule and health insurance premium plan contributions, and the General Fund financial impact.

NARRATIVE

Internal equity and minimizing wage compression: County negotiations with AFSCME for fiscal years 2019 through 2021 are ongoing. Consideration of 820 ILCS 105, which sets the new minimum wage at \$15 by January 1, 2025, must factor in to these negotiation outcomes. As the County deliberates these contracts in consideration of new legislation, maintaining internal equity among employee groups is an essential goal for county government, as well as maintaining the wage differential between staff, and supervisors and managers. Also relevant is the consideration of pay compression issues as entry level worker wages approach the wages of more experienced and tenured employees.

Improving employee recruitment & retention: Unusually high turnover followed the 2018 election. This has resulted in several offices being consistently understaffed, which has increased the burden on remaining staff. Here are the total number of departures by year, excluding RPC:

In the past two years (7/1/2017-6/30/2019), 181 employees left County employ; 15 left involuntarily, 26 retired, 115 resigned, and 25 jobs turned over due to election-related turnover and departmental reorganizations. I.e., 181 positions had to be refilled and retrained over 24 months, and more than 3 of 4 of the departures (115 resignations + 26 retirements) were fully voluntary.

In May, the employee count excluding RPC was 521; i.e., 156 departures over two years is roughly 1/3 of the General Unit census turnover in two years. Of the 156 departures, 42 were non-bargaining employees; 27 of those resigned, and 21 of those informed supervisors prior to leaving that they were leaving for more money / better opportunities; most of the remaining 42 were retirements. The cost of recruiting and training new employees is a significant factor.

Wages at the University and at the Cities of Champaign and Urbana are generally higher than County wages. It is essential for the County to consider comparative wages with other local government entities to attract and retain employees. More competitive wages would increase the number of applicants and provide the County with a greater and more diverse applicant pool. Examples of the decreasing applicant pool:

• Legal Clerk: 227 application in 2014; 307 applications in 2016; so far this year, 63

• Master Control Officer: 350 application in 2014, 86 applications in 2016, so far this year, 4

• Systems Administrator: 22 application in 2019; 4 applications in 2019

• Executive Assistant: 102 applications in 2013; 101 in 2014; 124 in 2016; 40 in 2019 The first two hire throughout the year. For the second two, there was one posting in each listed year.

Both Cities have 40 hour work weeks, so the wages above are calculated as [CityWage / 2080h * 1950h]

It is recommended the County establish and maintain wage increases that begin to encourage County staff to remain employed with the County. It is also recommended that increasing stability in the County's workforce be a high priority going into the 2020 election season.

Wage and salary schedule and health insurance premium plan contribution recommendation: Taking into consideration the aforementioned information, County Administration recommends a 3% increase to the non-bargaining salary ranges, and a 3.25% wage increase for non-bargaining employees in FY2020.

Non-bargaining employees contribute 14%, or \$113/month, towards the employee portion of health insurance. With the exception of the County contribution of \$70/month, dependent plans are paid by employees. The FY2020 recommendation is an employee contribution of 16% at an estimated cost of \$134/month (assumes a 4.5% plan cost increase), in conjunction with an increase in the County's contribution towards dependent plans at \$75/month.

Based on the average compensation of General Fund non-bargaining employees, the effective wage increase for employees covered under the County's health insurance plan when factoring in the increased contribution towards health insurance premiums is 2.8% for employee-only plans, and 2.9% for employee-plus plans.

General Fund financial impact:

The General Fund financial impact of these recommendations, based on current staffing, is projected to

cost \$240,000 in wage increases and \$36,000 in benefit cost increases (IMRF, FICA and Medicaid), offset by employees' increased contributions towards health insurance costs, estimated to reduce the County's Health Insurance expenditures by \$28,000. The net General Fund financial impact is projected to be \$248,000.

REQUESTED ACTION:

The Champaign County Board approves a 3.25% across the board wage increase for non-bargaining employees, and a 3% increase to the non-bargaining salary ranges effective January 1, 2020. The Board further approves that non-bargaining employees, with the exception of the Regional Planning Commission, contribute 16% of the cost of the single plan premium for health insurance in FY2020; and, that the County contribute \$75/month to the cost of dependent coverage, in addition to the contribution the County makes to the single plan premium for those employees who enroll in dependent coverage for FY2020.

RESOLUTION APPROVING FY2020 SALARY ADMINISTRATION and BENEFITS CONTRIBUTION PLAN FOR NON-BARGAINING EMPLOYEES

WHEREAS, pursuant to Chapter 9 of the Champaign County Personnel Policy, the Champaign County Board annually determines the salary administration adjustments for non-bargaining employees to be included in the ensuing fiscal year budget; and

WHEREAS, the County Board determines on an annual basis the contribution to the County's health insurance plan that will be made by the non-bargaining employees; and

WHEREAS, County Executive recommends to the County Board the following Salary Administration and Benefits Contribution Plan for the Non- Bargaining Employees, excluding employees of the Regional Planning Commission, to be adopted for FY2020:

- A 3.25% across the board wage increase effective January 1, 2020; and
- A 3% increase to the salary ranges for non-bargaining employees effective January 1, 2020;
- Non-Bargaining Employees shall contribute 16% of the cost of the single plan premium for health insurance in FY2020, and the County will contribute \$75 per month to the cost of dependent coverage, in addition to the contribution the County makes to the single plan premium for those employees who enroll in dependent coverage for 2020;

NOW, THEREFORE, BE IT RESOLVED by the County Board of Champaign County that the following Salary Administration and Benefits Contribution Plan for the Non-Bargaining Employees, excluding employees of the Regional Planning Commission shall be adopted for FY2020:

- A 3.25% across the board wage increase effective January 1, 2020; and
- A 3% increase to the salary ranges for non-bargaining employees effective January 1, 2020;
- Non-Bargaining Employees shall contribute 16% of the cost of the single plan premium for health insurance in FY2020, and the County will contribute \$75 per month to the cost of dependent coverage, in addition to the contribution the County makes to the single plan premium for those employees who enroll in dependent coverage for 2020;
