RESOLUTION NO. 2020-336

**A RESOLUTION APPOINTING CAMERON RAAB AS A COUNTY BOARD MEMBER
IN DISTRICT 6 TO REPLACE MIKE INGRAM FOR AN UNEXPIRED TERM ENDING
NOVEMBER 30, 2022**

WHEREAS, Mike Ingram, a County Board Member in District 6 for Champaign County, submitted their resignation from that office effective December 1, 2020; and

WHEREAS, Pursuant to 10 ILCS 5/25-11, when a vacancy occurs in any elective county office, the county board shall declare that such vacancy exists and notification thereof shall be given to the county central committee of each established political party, and the vacancy shall be filled within 60 days by appointment of the Chairman of the County Board with the advice and consent of the County Board; and

WHEREAS, The Champaign County Board Chair sent notification of the vacancy to the County Central Committee of each established political party; and

WHEREAS, the County Board Chair recommends the appointment of Cameron Raab to fill the unexpired term of a County Board Member in District 6 ending on November 30, 2022; and

NOW, THEREFORE BE IT RESOLVED By the County Board of Champaign County that the appointment of Cameron Raab to fill the unexpired term ending November 30, 2022 of Champaign County Board Member District 6 is hereby approved.
