The Champaign County Farm Bureau works tirelessly on issues impacting our membership and all residents of the rural areas of the county. We, as Past Presidents of the Champaign County Farm Bureau, have engaged with both Democrats and Republicans on issues such as drainage, zoning, green energy ordinances, and police presence in rural areas. We urge you to consider the maps that Mrs. Kloepfel submitted to the board for consideration and ask that you specifically consider Plan 1 and Plan 5A.

Both Plan 1 and Plan 5A will provide a greater voice to the rural and small-town residents of this county. It better maintains the communities of interest than Plan 11 and creates more compact districts that preserve the voice and representation of the rural areas of Champaign County.

As leaders of the Champaign County Farm Bureau, we pledged to serve our members and to leave our organization in a better place than when we started. The Champaign County Board has that same duty, the duty to serve all of the citizens of Champaign County and to leave this county in a better place than when you started your tenure on the board. Once again, we urge you to preserve the voice of the rural citizens of Champaign County and to enact either Plan 1 or Plan 5A.
