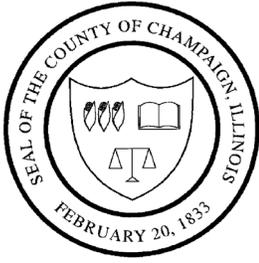

The County Board of Champaign County, Illinois met at a Regular Meeting, Thursday, February 19, 2026, at 6:30 PM in the Shields-Carter Meeting Room, Bennett Administrative Center, 102 East Main Street, Urbana, Illinois, County Executive Steve Summers presiding and Matthew Cross as Clerk of the meeting.

**ROLL CALL**

Roll call showed the following members present: Vanichtheeranont, Wiggs, Wilson, Arres, Cagle, Crane, Esry, Farney, Fortado, Hanauer-Friedman, Lokshin, Peugh, Rodriguez, Settles, Sexton, Sullard, Thorsland, and Locke – 18; late: Carter (arrived sometime before 6:40 PM) – 1; absent: Cowart, Fava, and Rogers – 3. County Executive Summers declared a quorum present and the Board competent to conduct business. Due to the length of the meeting, various board members were occasionally not present in the room for votes, the specifics of which could not be discerned on voice votes but are noted on roll-call votes.

**PRAYER & PLEDGE OF ALLEGIANCE**

In lieu of a prayer, County Executive Summers held a moment of silence for the recent passing of Rev. Jesse Jackson, and the Pledge of Allegiance to the Flag was recited.

**READ NOTICE OF MEETING**

The Clerk read the Notice of the Meeting, said Notice having been published in the *News Gazette* on February 5, February 12, and February 18, 2026.

**EMPLOYEE RECOGNITION**

Board Member Wilson offered a motion to adopt Resolution No. 2026-39 Honoring County Employees for Years of Service; Board Member Arres seconded. Board Member Vanichtheeranont read the entire text of the resolution. County Director of Administration Michelle Jett was invited to speak and praised the service of Chuck Chaney. Probation and Court Services Director Shannon Siders was invited to speak and praised the service of Lacy Busboom and Jennifer Crites. County Circuit Clerk Susan McGrath was invited to speak and praised the service of Nicole Liffick. The motion carried by unanimous voice vote.

Board Member Sexton offered a motion to adopt Resolution No. 2026-40 Honoring Retiring County Employees; Board Member Farney seconded. Board Member Vanichtheeranont read the entire text of the resolution. The motion carried by unanimous voice vote.

**RESOLUTION No. 2026-26**

Board Member Lokshin offered a motion to adopt Resolution No. 2026-26 amending the

Schedule of Authorized Positions in the Administrative Services Department – Program Director, Therapist, Case Manager, and Family Engagement; Board Member Farney seconded. Board Chair Locke noted the resolution had been tabled in the January Regular County Board Meeting and explained that the grant stakeholders were continuing to have fruitful discussions.

Board Chair Locke moved to table the resolution indefinitely; Board Member Peugh seconded. Board Members Farney and Sullard stated their discomfort with an indefinite tabling, preferring to table until the March or April Regular County Board Meetings. Board Chair Locke stated that it was not the Board's responsibility to directly manage grants under the Regional Planning Commission but stated the resolution could be reintroduced at a later date, if necessary. Board Member Wilson stated that the grant should not be administered through the County Executive's Office; he requested a status update from the grant stakeholders in 90 days. Board Member Carter asked about the status of the current grant funds; Board Chair Locke stated the current grant runs through June 2026, but the grant renewal is required in March. The motion to table Resolution No. 2026-26 indefinitely passed by voice vote.

## **PUBLIC INPUT**

Benjamin Beaupre, of Champaign, compared the recent violent and repressive actions of the Department of Homeland Security and Immigration and Customs Enforcement (ICE) to historic contemporaries in the Fugitive Slave Act of 1850, the Ku Klux Klan of the early 20th century, and *Gestapo* police of Nazi Germany.

Jim McGuire, of Champaign Township, spoke against Resolution No. 2026-43 supporting the Responsibility in Firearm Legislation (RIFL) Act legislation, spoke against County Executive Summers' recent executive order restricting ICE activities in county facilities, spoke against the SAFE-T Act, and asked the Board to support state legislation allowing election judges to work shifts on election day.

Urbana Police Chief Larry Boone spoke in support of Resolution No. 2026-43 supporting the RIFL Act legislation.

Reynaldo Camas, of Champaign, spoke in support of Resolution No. 2026-43 supporting the RIFL Act legislation, spoke about recent negative interactions with Board Member Carter and defended his right to speak during public input at County Board meetings.

County Clerk and Recorder Aaron Ammons spoke about the delayed County Audit, which may bar his office from state reimbursement grants for election expenses, if not completed by May 2026. The various reimbursements will total more than \$250,000. He also spoke about County Administration deducting funds from his department to pay for union-negotiated employee bonuses.

County Circuit Clerk Susan McGrath spoke about County Administration deducting funds from her department to pay for union-negotiated employee bonuses, and questioned why the Board decided to strike Resolution No. 2026-51 appropriating funds to cover a shortfall in personnel lines for FY2025 without informing her.

Rebekah Mangels of Champaign spoke against artificial intelligence (AI) data centers and in support of the proposed Data Center Task Force. She distributed a document with findings and recommendations for the Board to consider regarding AI, data centers, and the proposed task force.

Isabel Scott of Champaign spoke against AI data centers and AI, in general; she spoke in support of the proposed Data Center Task Force.

Zev Alexander of Champaign spoke against AI and tech billionaires and spoke in support of the proposed Data Center Task Force.

Alice Smith of Urbana spoke about community water needs, noting they are at odds with those of AI data centers, and spoke in support of the proposed Data Center Task Force.

Farah Abi-Akar of Urbana spoke against data centers and in support of the proposed Data Center Task Force.

Board Member Sullard offered a motion to suspend County Board Rule (Resolution No. 2025-64, X. E. 6) that prevent board members from “engaging in dialogue with members of the public during public input”; Board Member Lokshin seconded. The motion carried by unanimous voice vote.

County Auditor George Danos spoke about the delayed County Audit, noting the delay has increased significantly since being taken over by County Administration. He also noted his refusal to approve non-compliant purchases due to his inability to investigate those purchases. He asked the Board to restore the County Audit responsibilities to the Auditor’s Office. Board Member Sullard stated that Auditor Danos’s refusal to review expenses for non-compliance was in violation of statute; Auditor Danos stated to approve non-compliant expenses without proper review would be negligent and in violation of the intent of the statute. Board Member Peugh passionately requested the completion of the County Audit; County Executive Summers reminded Board Member Peugh to refrain from using obscene or profane language. Board Member Hanauer-Friedman blamed Auditor Danos for the delayed County Audit.

Board Member Farney moved to close public input; Board Member Sullard seconded. Board Member Settles objected to the closure motion as she had unasked questions. Board Chair Locke suggested the discussion with Auditor Danos could continue later in the Agenda, where appropriate. Board Member Fortado noted that Robert’s Rules of Order dictated that a closure motion is not a debatable action and requires a two-thirds majority for passage. The motion to close public input failed by roll-call vote:

Board Member Fortado offered a motion to extend public input by 15 minutes for board member questions of Auditor Danos, as the allotted 60 minutes had been exceeded; Board Chair Locke seconded. The motion carried by voice vote. Board Member Settles asked about personnel in the Auditor's Office; Auditor Danos stated that five staff members were added to the new County Finance Department, replacing the potential Auditor's Office staff. Board Member Settles asked how much external auditor CliffordLarsonAllen is costing the county; Auditor Danos stated more than \$100,000 per year for the external audit and about \$70,000 for creating an annual Comprehensive Financial Report template; Board Member Lokshin noted that the external audit is statutorily required. Board Member Carter spoke about a board member faction that refuses to work with Auditor Danos despite voters rejecting the ballot initiative to eliminate the office and re-electing Auditor Danos. Board Member Wilson spoke about Auditor Danos' refusal to sign off on non-compliant purchases and requested a report on both the statute and compliance. Board Member Lokshin asked Auditor Danos if he took responsibility for the delayed audit; Auditor Danos defended his record as County Auditor and blamed the Board for exasperating the delay. Board Chair Locke provided background on the history of Auditor Danos' handling of the County Audit; Board Chair Locke and Auditor Danos proceeded to shout at each other. State's Attorney Julia Rietz interjected and advised the Board to end the discussion with Auditor Danos and continue with the meeting Agenda; Board Chair Locke ignored the advice of State's Attorney Rietz and continued shouting at Auditor Danos. Board Member Fortado noted that Auditor Danos has only once delivered an on-time County Audit during his tenure in office; she requested an accounting of the costs of the County Audit.

### **PRESENTATION**

County Executive Summers noted that representatives of the Prairie Research Institute were not available to present on the Mahomet Aquifer Mapping Results.

DREAAM Assistant Director of Community Services Kathy Garrison gave a presentation on DREAAM's American Rescue Plan Act (ARPA) funded HOPE gun violence response program; HOPE Street Outreach Leader Travon Pickens spoke about the Street Outreach program. Board Member Rodriguez asked about mediations; Leader Pickens spoke about training, real-life procedures, and how needs are assessed and resolved. Assistant Director Garrison and Board Members Peugh and Carter praised the Street Outreach mediation work. Board Member Wilson asked how HOPE is aiding in restorative justice for victims; Assistant Director Garrison spoke about the victim services. Board Member Carter asked how often participants meet; Assistant Director Garrison stated that meetings have no strict schedule; Leader Pickens stated that meeting times and places are unique, individually and situationally dependents and he spoke about daily neighborhood check-ins, regular meetings, and individual experiences beyond their neighborhood, noting all forms require careful engagement.

ARPA Project Manager Kathy Larson provided a brief update on various ARPA-funded projects, noting the memo in the Agenda Packet. Board Member Fortado suggested, at the March Regular County Board Meeting, the Board set timelines for completion for the outstanding projects, noting that if the Rural Broadband Project were to miss the April phase I status deadline, it would raise serious concerns. Board Members Fortado and Wilson discussed the need to establish a plan to recover ARPA funds for project that may not be able to be completed and plan to redeploy those funds elsewhere. Director Jett was invited to join the discussion and stated she will provide the Board with an update memo on the Rural Broadband Project from Volo, who feels confident they can complete the project on time, but noted that any unspent funds allocated to that would need to be spent on something similar. Board Member Carter asked about the SLEEP program and the Economic Development Corporation small business grant program; Project Manager Larson stated that SLEEP had 57 clients and spent approximately \$115,000 and that she has no new information on the small business grant program, where it last stood at 31 grants administered. Board Member Fortado stated the Board should amend the SLEEP agreement to increase the budget for outreach and consider additional neighborhoods, including incorporated areas adjacent to the unincorporated areas currently served. Board Chair Locke asked why the Garden Hills project funds have not been spent; Project Manager Larson stated that the invoice had been submitted but more documentation is required before submitting the funds. Director Jett asked the Board to direct her to explore expanding the SLEEP coverage area; the board affirmed. Board Member Fortado that SLEEP continue to target neighborhoods in need; Director Jett suggested SLEEP team with HOPE for outreach.

County Executive Summers noted the Broadband project update in the Agenda Packet.

## **COMMUNICATIONS**

Board Member Peugh stated his opposition to data centers and spoke about the expense and usefulness of outside staffing for the internal County Audit.

Board Member Carter spoke about Black History Month and her dedication to the black community.

Board Member Wilson stated his unequivocal support for ICE.

Board Member Fortado noted a documentary screening on the Don Moyer Boys and Girls Club at the Virginia Theater in Champaign on February 20, 2026.

### **APPROVAL OF MINUTES**

Board Member Vanichtheeranont offered an omnibus motion to approve the minutes of the Regular Meeting of the County Board on January 22, 2026 and the Study Session on January 27, 2026; Board Member Settles seconded. The motion carried by unanimous voice vote.

### **STANDING COMMITTEES**

County Executive Summers noted that the Summaries of Action Taken for County Facilities Committee of February 3, 2026, and Environment and Land Use Committee of February 5, 2026, were received and placed on file.

Board Member Thorsland offered a motion to adopt Resolution No. 2026-41 authorizing the creation of a Data Center Activities Task Force as a County Board Select Committee; Board Member Rodriguez seconded. Board Member Thorsland gave background on the current data center ordinance, noting that it was written with small-scale data centers in mind, before the proliferation of the large-scale centers. Board Member Rodriguez thanked speakers for their opinions during Public Input, especially Rebekah Mangels' information sheet. The motion carried by unanimous roll-call vote:

## **AREAS OF RESPONSIBILITY**

County Executive Summers noted that the Summary of Action Taken for Committee of the Whole Meeting (Justice and Social Services; Finance; *and* Policy, Personnel, and Appointments) of February 10, 2026, was received and placed on file.

Board Member Hanauer-Friedman offered a motion to adopt Resolution No. 2026-43 supporting the Responsibility in Firearm Legislation (RIFL) Act; Board Member Thorsland seconded. RIFL Act advocate Anthony Douglas, MD, was invited to join the discussion. Board Member Farney requested a roll-call vote for the resolution. Board Member Wilson stated his opposition to the RIFL Act legislation and read the text of the Second Amendment of the Constitution. Board Member Lokshin stated that the Second Amendment does not absolve responsibility. Board Member Thorsland thanked Dr. Douglas for his work and attendance and noted that the RIFL Act legislation does prevent or even restrict lawful gun ownership and spoke about responsible gun ownership. Board Member Hanauer-Friedman asked Dr. Douglas to speak about the RIFL Act; he stated that the legislation has been review by legal experts and they determined it poses no constitutional issues, as it is a effort to regulate commerce within the state, and he spoke on the prevalence of gun violence, especially as an instrument for suicide. Board Member Fortado spoke about the context of the Second Amendment. Board Member Carter spoke about the prevalence of gun violence and its expansion in the 1990s in Champaign County. Board Member Wilson spoke about the Constitution and the Bill of Rights and stated that the greatest crime is not gun violence but abortion. Board Member Hanauer-Friedman called the question. County Executive Summers noted the Adult Redeploy Illinois Grant update in the Agenda Packet.

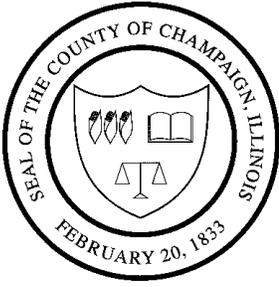

**RE: Additional Deputy Sheriff Position**

As you know, for several years the Village of Savoy has contracted with the Champaign County Sheriff's Office to provide police services. As part of that contract, three full-time deputies are assigned to patrol the Village. After discussions with the Village of Savoy on an upcoming contract renewal, it has been mutually decided to add a fourth deputy to the contract. As with the other three deputy positions, this fourth deputy position will be fully reimbursed by the Village of Savoy.

As part of this ongoing collaboration, I am asking the County Board to approve two things:

1. As our current authorized number of deputies does not allow for this additional deputy, I am respectfully requesting the County Board increase the number of authorized deputies by one (resolution attached).
2. Because there are some initial costs for an additional deputy position, I am respectfully requesting the County Board approve a Budget Amendment to cover initial costs that are not currently in our FY26 budget. These costs will be reimbursed by the Village of Savoy in this Fiscal Year.

AN INTERGOVERNMENTAL COST SHARING AGREEMENT  
BETWEEN THE COUNTY OF CHAMPAIGN,

FOR RESIDENTIAL ELECTRONICS COLLECTIONS IN 2026 AND

HOUSEHOLD HAZARDOUS WASTE COLLECTION IN 2026

THIS AGREEMENT is made and entered into by and between the County of Champaign and the following Illinois municipal corporations: the City of Champaign, the City of Urbana, and the Village of Savoy, effective on the last date signed by a party hereto. The foregoing entities will hereafter be noted as “the parties.”

WHEREAS, Section 10 of Article VII of the Illinois Constitution of 1970, and 5 ILCS 220/1, *et seq.* enable the parties to enter into agreements among themselves and provide authority for intergovernmental cooperation; and

WHEREAS, the parties find it to be most cost effective to mutually combine efforts and to share in the costs associated with Residential Electronics Collections to be held on May 15-16, 2026, and October 9-10, 2026, at Parkland College campus in Champaign, Illinois and costs associated with the Illinois Environmental Protection Agency (IEPA)-Sponsored One-Day Household Hazardous Waste Collection to be held on August 7-8, 2026 at the State Farm Center Southwest Parking Lot in Champaign, Illinois (hereinafter referred to as “events”). These costs include:

For the Residential Electronics Collection events:

- a) One-time flat-rate collection fee payment of up to \$23,000 per event to A-Team Recyclers due by the end of the day on the start date of each event;
- b) The cost of two golf carts at \$275 per two-days at each event.

For the Illinois Environmental Protection Agency-Sponsored One-Day Household Hazardous Waste Collection event:

- c) The event fee of \$3,000 for use of State Farm Center Southwest Parking Lot for two days at \$1,500 per day.
- d) The cost of traffic patrol services to be provided by one traffic patrol person, not expected to exceed \$900 for the event.
- e) The cost of approximately \$910 for rental of an overhead 10’x 10’ tent with sides for two days in the event of unsuitable weather conditions.
- f) The cost of one golf cart at \$500 per two days at the event.

WHEREAS, the cost contribution required of each party is provided in this Agreement;

NOW, THEREFORE, in consideration of the mutual covenants contained herein, the parties agree as follows:

### Section 1. Purpose

1-1. This Agreement outlines a cost-sharing arrangement between the parties for the purpose of administering the events in 2026. Costs will include:

For the Residential Electronics Collection events:

- a. Payment of a one-time flat-rate collection fee payment of up to \$23,000 per event to A-Team Recyclers due by the end of the day on the start date of each event;
- b. Payment for rental of two golf carts at \$275 per two-days at each event;

For the IEPA-Sponsored One-Day Household Hazardous Waste Collection event:

- c. Payment of an event fee of \$3,000 to the State Farm Center, University of Illinois at Urbana-Champaign, for use of the State Farm Center Southwest Parking Lot for two days at \$1,500 per day;
- d. Payment for traffic patrol services to be provided by one traffic patrol person, not expected to exceed \$900 for the event;
- e. Payment of approximately \$910 for rental of an overhead 10'x 10' tent with sides for two days in the event of unsuitable weather conditions;
- f. Payment for one golf cart at \$500 per two days at the event; and

### Section 2. Terms

2-1. The terms of this Agreement shall be from the date last signed by the parties until 60 days following the final event, unless amended by agreement of the parties.

### Section 3. Responsibilities

3-1. The parties understand and agree that of the parties to this Agreement, only the County of Champaign shall enter into a contract with the A-Team Recyclers and with Parkland College for the Residential Electronics Collections and with the IEPA and with the State Farm Center for the IEPA-Sponsored One-Day Household Hazardous Waste Collection event. However, the County of Champaign shall be entering into said contract on behalf of the other parties as well, and Champaign County agrees that it shall not enter into said contract unless it specifically names the other parties to this

agreement as third party beneficiaries of that contract. Champaign County shall obtain approval of the form of said contract with the contact from each of the parties to this Agreement prior to executing said contract.

3-2. Each party is responsible for contributing its share of the total costs for the events under this Agreement, according to the percentages and up to the maximums specified in Section 4 (Cost-Sharing) of this Agreement.

3-3. Each party is also responsible for coordinating information requests from the other parties in a timely manner.

Section 4. Cost Sharing

4.1 The parties agree to share, according to the percentages shown in Table 4.1, total costs not to exceed the Maximum Total Cost shown for each event:

Washington Street, Urbana, IL 61802.

Section 6. Amendments.

This agreement may be amended only in writing signed by all parties.

Section 7. Survival of Provisions.

Any terms of this Agreement that by their nature extend after the end of the Agreement, whether by way of expiration or termination, will remain in effect until fulfilled.

## Champaign County Solid Waste Management Plan Annual Report 2025

### **Background**

Champaign County submitted its sixth Solid Waste Management Plan on August 18<sup>th</sup>, 2022. The update covered a five-year planning period until 2027.

On December 3<sup>rd</sup>, 2025, the Champaign County Clerk was notified that the Illinois Environmental Protection Agency (IEPA) is implementing requirements which state that municipalities and counties must submit annual reports reviewing the implementation of the current Solid Waste Management Plan.

### **Solid Waste Management Plan Goals**

#### High Priority Goals:

1. Publicize information about material reduce, reuse, recycle options in Champaign County.
2. Review Champaign Ordinances to consider pre/post-consumer food compost land uses.
3. Support convenient and consistent collection options for household hazardous waste and recycling or residents' electronics items.
4. Encourage development of improved recycling options for batteries, unwanted medications, pharmaceuticals and sharps.

#### Medium Priority Goals:

1. Improve trash disposal options and recycling drop-off options for outlying rural residents.
2. Support initiatives that discourage the use of single-use plastics.
3. Encourage development of separate source glass bottle/container drop-offs or collection services.
4. Promote "greenscaping" and home management of leaves, yard trimmings & brush.
5. Evaluate Champaign County restrictions on the open burning of landscape waste to encourage composting of leaves and landscape trimmings and brush.
6. Promote increased recycling of construction and demolition debris.

### **Annual Review Requirements**

The requirements of the review, pursuant to the Local Solid Waste Disposal Act, *415 ILCS 10/5*, are as follows:

- a) An accounting of the quantity of waste received by those pollution control facilities included in the plan.

- b) If revenue bonds have been issued to finance a new pollution control facility, an account of the adequacy of the quantity of waste flow, and the effectiveness of those measures taken to guarantee waste flow to the facility to ensure that all bond obligations will be satisfied.
- c) If the new pollution control facility called for by the plan has not gone into operation, a report on the progress made towards bringing the facility into operation, including those additional measures not previously identified in the plan which are intended to be implemented, which would guarantee a constant flow of a given amount of solid waste to a given facility or facilities.
- d) A review of the 5-year solid waste forecast and the adequacy of the policies provided for the certified plan to meet that projected solid waste disposal need.
- e) Every fifth year after the certification of the plan, a review of the 20-year solid waste forecast and the adequacy of the policies provided for in the certified plan to meet that projected solid waste disposal need.

#### **Annual Review**

- A) No pollution control facilities were included in the most recent Solid Waste Management Plan.
- B) Revenue bonds have not been issued to finance a new pollution control facility in the reporting year.
- C) Champaign County has not received plans for a new pollution control facility within the 2025 calendar year.
- D) The forecasted solid waste disposal needs remain consistent with standards outlined in the current Solid Waste Management Plan.
- E) Reporting year 2025 is the third year of the current adopted Solid Waste Management Plan.

#### **Champaign County Waste Hauler Licenses**

Champaign County collected \$5,656 from waste hauler license fees during the 2025 calendar year.

Currently, Champaign County does not require waste haulers to report data on waste collected.

#### **Progress Made Towards Goals**

- Champaign County offers public notice of Residential Electronic Collection events and Household Hazardous Waste events.

- The Champaign County Zoning Ordinance included additional verbiage and land uses under Case 058-AT-22 on February 23<sup>rd</sup> 2023. Champaign County did not receive applications for any such facilities in the calendar year 2025 but continues to support lawful development of such facilities.
- Champaign County offers battery recycling drop-boxes for employee and citizen use.
- Champaign County continues to financially support Champaign County Environmental Stewards (CCES). CCES is a non-profit that is currently funding a facility for year-round recycling options for household hazardous waste.
- Champaign County continues to financially support the Product Stewardship Council. The Illinois chapter is dedicated to environmental sustainability in the form of extended producer responsibility.
- The Department of Planning & Zoning directs residents of the unincorporated area of the County to disposal and recycling locations as inquiries arise.

- RPC will be responsible for due diligence costs (inspections, surveys, appraisals) and any financing-related expenses.
- The seller will cover state transfer taxes, title insurance policy, broker commissions, and deed recording costs.
- Closing Timeline: Approximately 30 days after completion of the due diligence review period, unless otherwise agreed by the parties.

Ordinance No. 742 Establishing the Rules and Regulations Governing the Sale and Consumption of Alcoholic Liquor in Champaign County, Illinois was approved on March 31, 2005. Section 8C details Liquor License Application Fees and this section has not been amended since 2005.

As the Liquor Commissioner, I am proposing a 7% increase to each license class along with an annual increase by the Consumer Price Index (CPI) defined in the Consumer Price Index for all Urban Consumers (CPI-U) Series All Items Midwest – Size B/C.

Also, a Class E Temporary License is valid for three consecutive days. There is a daily fee for any additional days beyond the first three and I am proposing a \$50/per day fee for each additional day.

Ordinance No. 2026-6 will amend section 8C of the current ordinance by adding these changes.

**Background:** To continue to receive rural public transportation operating funding, Champaign County is required to submit grant applications annually for FTA section 5311 (Rural Public Transportation) and IL Downstate Operating Assistance Program (DOAP). These grants are awarded based on the Illinois Department of Transportation’s (IDOT) Fiscal Year (July 1, 2026 - June 30, 2027). The separate applications were prepared by RPC staff with input from Champaign-Urbana Mass Transit District staff and will be submitted online.

#### FY27 SECTION 5311 AND DOAP GRANT APPLICATION BUDGET

Allocated federal funding for FY2027 is \$ 177,721, while the allocated DOAP state funding is \$1,306,809. Total available funding is \$1,484,530; however, the amount of DOAP funding that Champaign County and its operator can obtain will depend on their ability to source local match funding. The proposed FY2027 budget is based on FY2026 budget and projected expenses and applied known changes for FY2027. The total federal and state request for FY2027 is \$ 1,484,530.

**Pre-Bid Effort**

The Project Team targeted qualified contractors to solicit interest and bids. Bailey Edward followed up with the Contractors to clarify the scope of the project, provide information, and confirm overall Prime Contractor commitment to providing bids in efforts to receive competitive bids. The plans were posted in a plan room and printed, and electronic copies were made available at our offices. The select documents were also available for free download from the Champaign County web site.

**Bid Results**

The program aims to curb community violence through increased lighting and security.

#### **Opioid Settlement Task Force**

- Fire Protection District's have received their automated chest compression devices and have been hosting trainings with their team. They've indicated they're happy with the ease of use of the devices
- Two applications recently requested, no requests currently pending
- Board members and the Champaign County Drug Court team were invited to tour C-U at Home's new mid-barrier facility on Mattis Ave. The first 14 participants moved in at the beginning of March and the transition is going smoothly
- Working w/ CUPHD to stock overdose prevention kits
- Research into MAT, MRT, harm reduction, and service gaps
- Quarterly Opioid Expense reporting

#### **Adult Redeploy Illinois (ARI)/Drug Court**

- Current grant year is the final of a 3-year grant. Applications for the new 3-year cycle are expected to be available in March and due likely by the beginning of May
  - We had a recent meeting with the internal and external stakeholders to prepare our application and discuss direction of the program
- Site visit with ICJIA on April 10<sup>th</sup>
- Preparing and submitting monthly fiscal reports
- Completed Subaward Packets
- Coordination with subcontractors and subrecipients

#### **Firearms Safe Storage Strategies (FSSS)**

- Approximately 1,200 safes distributed
