
Dear Mr. Stohr:

My name is Terry Gattis and I live in Savoy, Illinois. I moved to the area just over a year ago and I am a retired Law Enforcement Officer of 27 years. As it relates to the use of the ARPA, I have had the opportunity to meet and speak with a number of the fine personnel of the Champaign County Sheriff's Office and it would appear having speaking to them, they are just barely staffed to simply respond to the basic calls for service within their jurisdiction. God forbid a situation happen like what just occurred last month when Officer Chris Oberheim was murdered, it could potentially cripple law enforcement services both within the county and the additional areas patrol services are provided. I would suggest funds be allocated to increase staffing not only for patrol services but for crime prevention initiatives. As we are all aware, the number of shootings in the Champaign / Urbana areas have continued to increase and having creative initiatives and the personnel to back them could only be of benefit. Additionally, based on information available, the downtown jail facility is consistently costing the County unnecessary money. The facility is outdated and there are significant safety concerns both for the Corrections Officers and the inmates. This facility should be considered to be closed and services combined at the other facility until a better facility could be built, which would then continue to put the Sheriff's Office and Champaign County ahead of others with a state of the art facility.

I have been talking to my neighbors in Garden Hills and collecting their signatures and the reasons they want street lighting. With the recent and continuous gunshots and shootings as well as the cars racing through the neighborhood after dark, it would be awesome if you would consider lighting, especially along Paula drive, as part of the ARP planning. Paula has bus stops (ie signs without benches or shelters) down its length, and it feels unsafe to cross the street to stand at unlit stops. Also, many residents have added Ring Doorbells for security, but the cameras are only as good as the lighting.

Please consider streetlights in Garden Hills for part of the ARP funding.
