VII. New Business

A. County & Township Motor Fuel Tax Claims April 2025

MOTION by Cagle to receive and place on file the County and Township Motor Fuel Tax Claims for April 2025; seconded by Sullard.

Upon vote, the MOTION CARRIED unanimously.

B. Resolution Awarding of Contract for Road Construction, Section #24-00472-00-RS

Blue discussed the bid tab results for CH 15, Section #24-00472-00-RS. The letting was held on May 6, 2025, for the recycling and asphalt overlay of County Road 15, from the west village limits of Sidney to the Vermilion County Line. Open Road Paving submitted the low bid of \$6,810,021.91. Blue recommended awarding the project to Open Road Paving.

MOTION by Sullard to approve the Resolution; seconded by Cagle.

Upon vote, the MOTION CARRIED unanimously.

C. Resolution Awarding of Contract for the Replacement of a Bridge Located on County Road 1300E in Ludlow Township, Section #22-24129-00-BR

Blue stated 2 contractors submitted bids on May 6, 2025, for the bridge deck replacement in Ludlow Township. Stark Excavating submitted the low bid of \$315,976.50. Blue recommended awarding the project to Stark Excavating.

MOTION by Sullard to approve the Resolution; seconded by Cagle.

Upon vote, the MOTION CARRIED unanimously.

D. Resolution for Contract Award Authority

Blue explained the need for a bridge deck replacement located north of Flatville, on the township line, (County Road 2400N) between Stanton and Rantoul Townships. Blue asked for award authority to be able to award the contract, as soon as possible, to the low bidder, if he believes the bid is in the best interest of the public.

MOTION by Carter to approve the Resolution; seconded by Peugh.

Upon vote, the MOTION CARRIED unanimously.

E. Petition Requesting and Resolution Approving Appropriation of Funds from the County Bridge Fund, St Joseph Township, Section #25-27153-00-BR

Blue discussed a bridge located on 1900E south of Windsor Road that needs the bridge deck replaced. The estimated cost of replacement is \$350,000. St Joseph Township is prepared to pay 50% of the local cost of the replacement.

MOTION by Sullard to approve the Resolution; seconded by Carter.

Upon vote, the MOTION CARRIED unanimously.

WHEREAS, in order to receive the most competitive bids and achieve timely construction of this project, it is in the best interest of Champaign County to award the contract as soon as possible; and



PETITION REQUESTING AND RESOLUTION APPROVING APPROPRIATION OF FUNDS FROM THE COUNTY BRIDGE FUND PURSUANT TO 605 ILCS 5/5-501

PETITION

Petitioner, <u>Chuck Billman</u>, hereby requests an appropriation of funds from the Champaign County Bridge Fund pursuant to 605 ILCS 5/5-501. In support of this petition, Petitioner states the following:

- l. Petitioner is the duly elected Highway Commissioner for the Urbana Road District, Champaign County, Illinois; and
- 2. There is a <u>Bridge</u> located on North Cottonwood Road between Sections 11 and 12 in Urbana Township, which is in poor condition; and
- 3. To ensure the adequacy of said structure for the traveling public, it is necessary that said bridge deck be replaced; and
- 4. The cost to <u>replace</u> the aforesaid bridge deck is estimated to be \$700,000 which will be more than .02% of the value of all the taxable property in the <u>Urbana</u> Road District, as equalized or assessed by the Department of Revenue; and
- 5. The tax rate for road purposes in the <u>Urbana</u> Road District was in each year for the last two (2) years not less than the maximum allowable rate provided for in Section 6-501 of the Illinois Highway Code (605 ILCS 5/6-501); and
- 6. The <u>Urbana</u> Road District is prepared to pay 50% of the local cost associated with the replacement of said structure.

WHEREAS, the County Board finds that based on the representations in the foregoing Petition, it is required pursuant to 605 ILCS 5/5-501 to provide the requested aid.


NOW, THEREFORE, BE IT RESOLVED by the County Board of Champaign County as follows:

- 1. The County Board hereby appropriates from the County Bridge Fund a sufficient sum to meet 50% of the local cost to replace the aforesaid structure.
- 2. The County Board hereby directs the County Engineer to cause plans and specifications to be prepared for said improvement.
- 3. The County Board hereby orders that said improvement be made under the general supervision of the County Engineer, by receiving bids for the improvements.
- 4. The County Board hereby directs the County Engineer to certify to the County Board when the work has been satisfactorily completed to meet his approval. Such certificate shall include an itemized account of the cost of all items of work incurred in the completion of said improvement and shall show the division of cost between the County and the Urbana Road District.
- 5. The County Board further directs the County Engineer to file said certificate with the clerk of the <u>Urbana</u> Road District.
 - 6. This Resolution shall become effective upon its adoption.
