I. Call to Order

Sam Byndom called the meeting to order at 6:30. The meeting occurred at the Urbana Middle School due to a lack of available space at the County's Brookens Center.

VI. Subcommittee Meetings

Sara shared the memos that the U of I class working on a database put together to scope out the project. She told the subcommittees that they could review them and give comments back. The class will be at the next RJTF meeting.

Esther asked about two points in the memo which seemed contradictory. Sam responded that the task force will be able to ask the class questions when they are at the next meeting.

The subcommittees except for the Restorative Justice subcommittees met during this meeting. See below for their minutes.

Susan spoke with the director of the Police Training Institute and said that he could give a presentation to the task force or to the Police Practices subcommittee. The group discussed

whether it would be efficient to have him speak to the task force. Ryan said it would be good for him to meet with the subcommittee but to hold off on planning that for now.

Sara brought up an email she sent to the group regarding the Adult Redeploy program funding available to the County through the State. It was noted that the County has ignored this opportunity in the past, and it is unlikely they would be able to put together an application before the October deadline. It will be considered as a recommendation for next year.

Amy brought up a talk on the book Post Traumatic Slave Syndrome by Joy DeGruy Wednesday, Oct. 5th.

I. Discussion of Next Steps

He contacted someone from the Story Corps National Public Radio project to ask for help with collecting stories. Someone offered to have a conversation with him and discuss technical challenges. David will email them back and keep the group informed. He also said that NPR could help put together a grant for this effort.
