COVID-19 Precautionary Measures
Interim Protocol and Calendar Changes

- I. On March 9, 2020, Governor Pritzker declared a [State of Emergency](#) in response to COVID-19, and on April 4, 2020, Gov. Pritzker [extended](#) that declaration. On March 20, 2020, Gov. Pritzker issued [Executive Order 2020-10](#), imposing Stay-at-Home limitations. On April 1, 2020, [Executive Order 2020-18](#) extended those limitations through April 30, 2020, and on April 30, 2020, a new [Disaster Proclamation](#) and Executive Orders [2020-32](#) and [2020-33](#) extended those limitations (with some exceptions) through May 29, 2020.
- II. Gov. Pritzker’s Executive Order [2020-30](#), issued on April 23, 2020, permits residential eviction actions to be commenced and nonresidential eviction orders to be enforced if the Court determines that the tenant poses “a direct threat to the health and safety of other tenants, an immediate and severe risk to property, or a violation of any applicable building code, health ordinance, or similar regulation.”
- III. On March 13, 2020, the Sixth Judicial Circuit, Champaign County, provided in [Precautionary Measures](#) the authority for each judge to establish interim protocols in light of that judge’s upcoming scheduled calls and hearings.
- IV. On March 16, 2020, Champaign County Administrative Order [2020-03](#) closed the Champaign County Courthouse from March 16 - 27, 2020. On April 3, 2020, Champaign County Admin. [Ord. 2020-05](#) extended the Courthouse’s closure to April 30, 2020, except for limited emergency matters, which must be coordinated through the Presiding Judge. On April 30, 2020, Champaign County Admin. [Ord. 2020-07](#) extended this closure (with modified exceptions) until June 1, 2020.
- V. On March 17, 2020, the Illinois Supreme Court established “guidelines in order to protect the health and safety of court patrons, staff, judges and the general public”, including the direction that “All non-essential court matters and proceedings should be continued or, where possible, conducted remotely via telephone or video or other electronic means.” [Ill.S.Ct. M.R. 30370](#). This order now has been amended [multiple times](#).
- VI. On March 20, 2020, Sixth Judicial Circuit Administrative [Order 2020-01](#) required “all courthouses within the 6th Judicial Circuit” to continue hearings set through April 10, 2020, unless they fell within a limited list of exceptions. On April 2, 2020, Sixth Judicial Circuit Administrative [Order 2020-03](#) extended the provisions of Admin. Ord. 2020-01 from April 10, 2020, through April 30, 2020,

and on April 30, 2020, Sixth Judicial Circuit Administrative Order 2020-06 extended its provisions through May 31, 2020.

- VII. Courtroom “D” conducts regular, non-emergency calls that gather large numbers of people.
- VIII. Avoiding large gatherings and maintaining social distance is essential at this time to mitigate the danger and to keep the number of infections requiring critical care below our health providers’ capacity to manage that care.
- IX. In order to comply with the requirements of the orders above, and to protect health and safety while still providing for the orderly operation of the Court’s essential functions, the Court has established the following Interim Protocol for Courtroom “D” as of May 4, 2020, which supersedes any previous Interim Protocol for Courtroom “D”:
 - A. **All hearings are canceled** through May 29, 2020, except as noted in the attached Table of Courtroom “D” Schedule Changes (counsel and self-represented litigants in May hearings that are proceeding as scheduled already have been contacted), and except Emergency Evictions (see below).
 - B. **Court will notify of Court rescheduling:** The Court will notify counsel and self-represented litigants of the new date for any hearing that the Court reschedules.
 - C. **Plaintiffs must notify of rescheduled dates for canceled 1st Appearances (Eviction and SC/LM), Citations and Rules to Show Cause:** Plaintiffs’ counsel for these canceled calls must:
 - i. Contact the Champaign County Circuit Clerk (217-384-3725) to obtain new settings (but if counsel is unable to do this through the Circuit Clerk by May 8, 2020, counsel may contact the Court by email (alusk@co.champaign.il.us) or telephone (217-384-1284));
 - ii. Send notice and file proof of service; and
 - iii. If Plaintiff intends to request a default judgment for non-appearance, warn the Defendant of that possibility in the sent notice.
 - D. **Dates have been added:** The Court has added dates to the Courtroom “D” schedule in June, July, and August to accommodate rescheduled large court calls. The Revised Courtroom “D” Schedule is attached.
 - E. **Volume reduced:** While the frequency of large calls has been increased, the number of cases that can be set for each has been reduced.
 - F. **Alias Summons/Citation:** If the Defendant in a canceled court call has not been served, Plaintiff’s counsel may notify the Court by email (alusk@co.champaign.il.us) or telephone (217-384-1284), or through the e-filing draft order system, and the Court will order Alias Summons/Citation/Rule to issue.
 - G. **Motion Calls:** For canceled Motion Calls, the Court will send notice to all parties setting a deadline to file objections/arguments, as indicated in the attached List of Changes for each canceled call. The Court then will decide
