## FREQUENTLY ASKED QUESTIONS

## Is the Probation Office open to the public?

- Yes, as of June 1, 2020, the Probation Office is open to the public on a limited basis. Our hours are 8:00 a.m. to 4:30 p.m., Monday through Friday.
- We are limiting the number of people reporting to the Probation Office. If you do not have a scheduled appointment, do not report to the Probation Office. In that case, please call your Probation Officer at (217) 384-3753 to schedule an appointment.

### How do I contact my Probation Officer?

- You can contact your Probation Officer by telephone at (217) 384-3753. If your officer is not available, your call will be forwarded to his/her voice mail. If you leave a message, your officer will return your call as soon as possible.
- You can also contact your officer by email. Generally, each officer's email address is his/her first initial and his/her last name @co.champaign.il.us (example: <a href="mailto:mwilliams@co.champaign.il.us">mwilliams@co.champaign.il.us</a>).
- You can also send your email to the Department's general email address (<u>courtservices@co.champaign.il.us</u>) and your email will be forwarded to your officer.

# • What if I was sentenced to Probation during the time the Probation Office has been closed?

o If you were sentenced to Probation during the time the Probation Office has been closed, your case has been assigned to a Probation Officer and it is likely that your Probation Officer has attempted to contact you by telephone or by mail. If you have not heard from a Probation Officer, please call the office at (217) 384-3753.

### What should I know about coming to the Courthouse and the Probation Office?

- Do not report to the Probation Office if you are sick. Call your Probation Officer to reschedule.
- Clients will be required to wear face coverings at all times while in the Probation Office.
- Upon entering the Courthouse, clients should be prepared to let Court Security Officers know the following:
  - ✓ The name of the Probation Officer they are seeing (or the group meeting they are attending).

- ✓ The time of their appointment. Visitors may only be admitted to the courthouse 10 minutes in advance of their scheduled appointment/group meeting.
- Only clients will be admitted to the Probation Office. Family members (including children), friends and others will not be admitted. Exceptions will be made for parents/guardians of juvenile clients.
- Any client needing assistance with access issues should contact their Probation Officer in advance.
- Visitors are not to enter the Probation Office if they have any of the following symptoms: fever, coughing, sneezing or shortness of breath.
- Visitors may be required to have their temperature taken.
- Visitors observed coughing or sneezing will be asked to leave the office and told to contact their Probation Officer to reschedule.
- Occupancy of the Probation Office waiting room is limited to 12 persons. If capacity is reached, clients and other visitors will be asked to wait in the hallway.
- To protect their own health and the health of those around them, visitors are asked to respect social distancing guidelines and to maintain 6 feet between themselves and others whenever possible. Social distancing practices will be facilitated by signage, spacing indicators, and seating arrangements.
- Commonly touched surfaces are being cleaned and disinfected frequently and hand sanitizer will be available in courtrooms and public offices.
