Summary

The monthly IEMA and local emergency radio tests were conducted. The monthly siren test was conducted. The agency hosted the EMA liaison meeting for the month of June. The agency posted articles and other information on social media outlets for severe weather preparedness and other activities. CCEMA attended the monthly Fire Chief's meeting. The office continues to work the grant funded emergency accountability equipment and software for the accountability of personnel and resources specifically for disasters and events, over 350 IDs produced for various responder agencies. CCEMA monitored, posted and consolidate reports of six severe weather events throughout the month. CCEMA responded with the Mobile Command Post for a missing child in the county June 11th and 12th. SAR team was put on stand-by to possibly assist Champaign County Sheriff's office with the infant location. Infant was found by deputy and SAR team stood down.
