Subject: February Board Report

Summary

Champaign County Emergency Management Agency (CCEMA) remains focused on the COVID-19 response and recovery with an emphasis on vaccine administration. This effort includes public messaging, oversight of the testing site at Marketplace Mall, and supporting the vaccination clinics. This period included a focus on establishing the vaccination clinic at the I Hotel on the University of Illinois campus. This will support all residents in Champaign County.

COVID-19 Response

John Dwyer continues to serve as the Emergency Operations Center (EOC) Manager to support response efforts for Champaign County during the Pandemic. Collin Rector, the Deputy EMA Coordinator, is serving as the Logistics Chief in the EOC, and he is supporting the vaccination clinic located at the I Hotel. **Champaign County has distributed 183,813 pieces of PPE** including N95 respirators, surgical masks, hand sanitizer, gloves, touchless thermometers, and other support items. CCEMA also maintains supervision of the Champaign County Testing Center near Marketplace Mall. **The center has tested 134,422 people** as of February 28 2021, since officially opening on May 19, 2020. The County EOC also established a PPE reserve that is stored at CUPHD in case of emergency. This is a 90-day stock to support first responders and the hospitals in case of resurgence.


Other Notable Events

- Attended monthly Community Safety – Emergency Planning, Response, and Outreach (CS-EPRO) Technical Advisory Group meeting - February 25th


Information Dissemination to Champaign County

CCEMA had **52,473 views** of its social media content and gained an additional **323 followers**.


Post Views
