General

1. One week shall be permitted for control system switch-over per facility. Contractor and owner shall coordinate this event and owner to take necessary steps to maintain facility functionality during this time. Contractor to make the determination as to how much "premium" time work occurs during this phase of the project, but otherwise, little-to-no work will be required to be performed on a premium time basis.
2. An additional pre-bid meeting shall be held on January 8, 2020 at 2:00 pm - meet at the Lyle Shields Conference Room, Brookens Administration Center, 1776 East Washington Street, Urbana, Illinois.
