10 Champaign. The meeting was called to order at 5:32 PM by President, Dr. Krista Jones.

14 Upon roll call, the following Board members were found to be present: Dr. Krista

16 Secretary/Treasurer, Dr. Kyle Fleming, Dr. Dorothy Vura-Weis and Mr. David Thies. Mr.  
17 Dave King was present at 5:34 PM. Mr. Bradley Clemmons was absent.

19 Also present were: Mr. Jim Roberts, CUPHD Director of Environmental Health.

21 **Approval of Agenda/Addendum**

23 Mr. Thies made a motion to approve the agenda. Dr. Kumar seconded the  
24 motion. With all in favor, the motion carried.

61 Mr. Roberts discussed the implementation of repeat violations between the two  
62 food codes. He explained that with a different enforcement policy there may be different  
63 triggers for fines.

65 Mr. Thies made a motion to approve the 2018-11-01 Resolution regarding an  
66 ordinance amending Chapter 5 of the Health Ordinance of Champaign County and  
67 adopting the Champaign County Public Health Department Retail Food Program  
68 Enforcement Policy. Dr. Fleming seconded the motion. With all in favor, the motion
