

Amendment No. 2 to Operating Agreement – Food and Commissary Services Agreement

THIS AMENDMENT NO. 2 (the “Amendment”), is entered into this 22nd day of July, 2019 by and between the **County of Champaign, Illinois** (the “County”), and **Aramark Correctional Services, LLC**, a Delaware limited liability company, having its principal place of business located at 2400 Market Street, Philadelphia PA 19103 (“Aramark”).

WHEREAS, on February 1, 2017, the parties entered into an Agreement for the management of the food service operation at the Champaign County Jail and the Champaign County Juvenile Detention Center (as amended, the “Agreement”);

WHEREAS, the parties acknowledge the need to address volatility in the cost of food commodities; and

WHEREAS, the parties desire to amend the provisions of the Agreement as follows, effective February 1, 2019 (the “Effective Date”).

NOW, THEREFORE, in consideration of the foregoing and of the mutual promises in the Agreement and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as set forth below. Capitalized terms used but not defined in this Amendment have the meanings ascribed to such terms in the Agreement.

1. **Per Meal Prices:** The price per meal set forth in Section 4 of the Agreement shall be changed as a result of an increase in the Consumer price Index as set forth in Attachment A. The new price per Adult meal charged to the County by Aramark shall be \$1.113 and the new price per Adult snacks shall be \$0.828. The new price per Juvenile meal charged to the County by Aramark shall be \$1.736 and the new price per Juvenile snacks shall be \$1.1268. These prices shall be effective from the Effective Date through January 31, 2020.

2. **Effect of Amendment:** Except as specifically set forth herein, all other terms and provisions of the Agreement shall remain unaffected by this Amendment and shall continue in full force and effect.
