FOOD SERVICE CONTRACT

The County of Champaign, located in Champaign-Urbana, Illinois, and Waugh Foods Inc., located at 701 Pinecrest in East Peoria, Illinois, entered into this contract the 23rd day of June, 2011 for food products and related supplies for Champaign County Nursing Home, located at 500 S. Art Bartell Road, Urbana, Illinois.

This contract commences on the 1^{st} day of July 2011 for a two (2) year term with one (1) single year renewal period and a (2) year term renewal period. The contract is not to exceed five (5) years.

The County of Champaign agrees to purchase a minimum of 90% of its food and related products from Waugh Foods, Inc.

Payment Terms: Invoices are to be paid within sixty (60) days after receipt of invoice. Invoices not paid within granted terms may be subject to a service charge not to exceed 6% per year.

Waugh Foods agrees to the following commitments to Champaign County Nursing Home during the contract period (as outlined in the Prime Vendor Program included with RFP 2011-009).

Smart Card Resident Tray Card Program: (no charge to the County)

Beverage (coffee & juice) equipment and service is available at no cost to the County.

Chemical dispensing equipment and service for your dish machine, pot & pan sink and hand soap is available at no cost to the County.

Waugh Express internet order entry system is available to the County to place orders with Waugh Foods at no cost to the County.

Rebate Tracking: Waugh Foods will track manufacturer rebates and reprint invoices or provide tracking reports to be submitted.

Delivery: Waugh Foods can provide up to 3 day / week delivery if needed. Deliveries will be made during the hours of 6:30 am - 12:00 pm. All orders are to be signed for by an authorized agent of the Nursing Home.

Right of refusal: The County reserves the right to refuse any goods at time of delivery. Once an order is signed and accepted the County has 48 hours to notify Waugh Foods of quality problems pertaining to fresh meats, poultry, fish, refrigerated items and fresh produce. Return of frozen products must be called in within 48 hours of delivery. All dry food and paper items must be called in within 30 days of delivery. All products without quality issues must be returned in original packaging and be a re-saleable condition. Waugh Foods Inc. follows the Federal HACCP regulations on this return policy.

Pricing: Prices listed in RFP 2011-009 shall be fixed for a period of 12 months from the beginning date of the contract. Included in the bid is the maximum mark-up that can be taken by item each subsequent year of the contract up to five years.

Business reviews: Waugh Foods will provide the Nursing Home monthly descending dollar usage reports as required in the RFP. In addition Waugh Foods will conduct business reviews with the management staff of the Nursing Home at least two times per year.

Termination of Contract: Either party may terminate this Contract at any time during the term, upon sixty (60) days notice to the other party.
