This letter concerns the former United Cerebral Palsy – Land of Lincoln Vocational Services program contracted through the Champaign County Developmental Disabilities Board. A letter requesting excess revenue was mailed to the UCPLL President/CEO on November 4, 2019. To date, excess revenue payment has not been received by the CCDDB.

This fee for service contract was advanced four monthly payments reconciled against claims entered into an online claims system. Total services billed (\$17,520 of eligible claims and \$4,720 of ineligible claims) prior to the termination of the contract were less than the advanced payment amount (\$20,000). Claims entered into the online system reveal excess revenue that is to be returned to the Champaign County Developmental Disabilities Board in the amount as stated below:

CCDDB - Vocational Services - \$2,480

Per section B.1. of the contract, "Provider will be paid \$40.00 per hour of service provided to or on behalf of PUNS enrolled program participants." Claims entered for participants not enrolled in the PUNS database equal \$4,720.

Section 17. d. of the contract states, "Upon termination of this Contract prior to the end date as provided by the terms of this Contract, the Provider shall return to the Board all revenues in excess of expenses as of the date of termination. Return of excess revenue shall be by check payable to the Board, no later than **fifteen** days after the notice of termination."

In addition to the excess revenue payment, the CCDDB has not received the FY19 audit, required to be submitted 120 days following the completion of the Provider's fiscal year ending on June 30, 2019.
