Program Summaries:

Draft program summaries were included in the Board packet. A Briefing Memorandum describing the program summary process was included in the packet as well. Applications were organized based on priorities and criteria established by the CCMHB. Ten points of alignment were delineated in the Briefing Memorandum as follows:

- 1. Applications supporting development of a System of Care for children and adolescents in Champaign County and our application for a Substance Abuse and Mental Health Services Administration (SAMHSA) Children's Initiative Grant.
- 2. Applications related to programs and services that promote access to services for adults with mental illnesses, substance abuse and/or developmental disabilities involved with the criminal justice system in Champaign County.
- 3. Applications related to programs and services that promote the goals and objectives of the Social Emotional Learning and On-site Consultation project for pre-school children.
- 4. Applications supporting programs and services that promote access for underserved populations identified in the Surgeon General's Report on Mental Health: Culture, Race, and Ethnicity and the consultation with Carl Bell, M.D.
- 5. Applications related to programs and services eligible for participation in the Medicaid Community Mental Health Services Program (i.e., Part 132) and Medicaid services for people with substance abuse treatment needs and developmental disabilities.
- 6. Applications related to programs and services for substance abuse treatment and prevention.

- 7. Applications related to compliance with the terms and conditions of the Memorandum of Understanding between the CCMHB and the Champaign County Developmental Disabilities Board (CCDDB).
- 8. Applications related to programs and services for adults and children that meet the DMH/DHS "eligible" definition (i.e., less severe mental illnesses).
- 9. Tier 3 Incumbent applications and non-aligned applications.
- 10. Analysis of Budget and Program connectedness and clarity for all grant-based applications.

Comments from agencies regarding their program summaries should be submitted to the CCMHB office before April 10, 2007.
