#### "Parenting with Love and Limits" Presentation:

Dr. Scott Sells of the Savannah Family Institute provided an overview of the "Parenting with Love and Limits (PLL)" program. The purpose of the presentation was to discuss the implementation of the evidence-based model of PLL through the CCMHB and implemented through an appropriate community service provider. The primary goals would be to (1) significantly increase parent involvement to 70% or higher to lower recidivism rates and (2) create a cost effective way to divert moderate high to high-risk juvenile offender for the JDC; and (3) to "retool" community mental health staff to increase overall effectiveness and lower their burnout rates.

Dr. Sells had a video presentation as well as a Powerpoint presentation. Question were taken from Board and audience members at the end of the presentation.
