FINANCIAL REPORT:

Acceptance of Expenditures:

The expenditure approval report was included in the Board packet.

MOTION: Mr. McClellan moved to accept the expenditures report as presented. Ms. Dannave seconded the motion. A voice vote was taken and the motion passed.

NEW BUSINESS:

Draft Three-Year Plan 2010-2012 with FY 2010 Objectives:

A draft of the Three-Year Plan with updated objectives for FY 2011 was included in the Board packet for review and comment. A final draft will be presented for approval at the November 16, 2010 Board meeting.

2011 Budget Documents:

A copy of the CCMHB, CCDDB, ACCESS Initiative, Quarter Cent for Public Safety and Drug court Fund budget documents and a copy of the budget presentation to the Champaign County Board was included in the Board packet for information only.

Excess Revenue Decision Memorandum:

The Mental Health Center of Champaign County (MHC) has excess revenue from two CCMHB grant funded contracts. The amount of this excess revenue is less than 20,000. The continuing state budget crisis with its reduced funding, eliminated programs and delayed payments has impacted the availability of mental health services. The MHC has requested permission from the CCMHB to use the excess revenue to fund psychiatric services in order to maintain current capacity. Although this request is counter to established CCMHB excess revenue policy, staff recommends an exception be made as part of an overarching strategy to mitigate the damage caused by actions taken by the State of Illinois.

MOTION: Dr. Gullerud moved to authorize the executive director to reprogram the FY10 excess revenue reported by the Mental Health Center of Champaign County in an amount not to exceed \$18,381 in order to support psychiatric services contract (s) predicated by program plan negotiation. Mr.

McClellan seconded the motion. A roll call vote was taken and all members vote aye. The motion passed.

Champaign County Specialty Courts:

Champaign Circuit Court Judge Jeffrey Ford and Ms. Sheila Ferguson, CEO of the Mental Health Center of Champaign County (MHC) reported on the status of a proposed Mental Health Court in Champaign County.

Draft Meeting Schedule and Allocation Timeline:

A draft schedule of meeting dates and deadlines for the 2012 allocation process was included in the Board packet for information only.
