So again, like I'm thinking about like what we fund as a DD board. So like a program that supports your understanding about legislative action and then to advocate might be another route if the fix is legislatively.

All kinds of people who participated in the survey, not just not just folks from one particular agency or you know walk of life or a certain disability type, but that this community is not welcoming to people with disabilities came up really strongly and that also same time this community is rich with amazing resources,

And they're just not available to everyone. So thank you for bringing that up again. That was just 2 years ago, apparently it's still true, but that Alliance for Inclusion and Respect that you mentioned could actually partner with you on specific advocacy items.

That is something that the DD board and mental health board do, in addition to funding programs. We do a lot of legislative advocacy.

It is not as easy for agencies to do that system advocacy as it used to be because of anti-lobbying laws. We are not bound by those anti lobbying laws, so we can partner with you on advocacy for the kind of changes in rules that will make your life better and maybe help this community get it together to be more welcoming.

Yeah, just a question because I think Tobie, it was you mentioned the services for more than one agency, and I know this came up when we were doing the funding but is the communication between the agencies themselves, is that pretty smooth or that they time that one when you're working with one agency and then you go to another for something if they

You could pay for tickets or fees for people to do fun things in the community or fund obviously opportunities.

So that is something that is going to be available hopefully. You know, I think if there's fun things in the community or advocacy opportunities that we can fund,

But fundamentally, the attorneys believe that the best way for us to do that is to fund an organization to to make payments. It may be a partnership with us as far as eligibility or what kind of what would the rules around accessing an emergency fund or the tickets for fun things look like.

You know, that could all be worked out. I think some of these organizations actually have a lot of experience with specific assistance. That's sort of the category generally.

So it is very possible to do a lot of the things that y'all are talking about. We do some of them already.

We can make them better, but absolutely we have to be partnering with you all to do it right.

Advice to you. I'm happy with the support I get now. I like, I like more money to keep.

Going to need support someday. I like to support and getting a job. No, I'm not sure if I'm running for that yet.

Think it's important to get money to the programs that make that support possible. Also, like to be part of more events out of town.

Like, I mean, the chance to be an advocate. Like to speak up, I don't usually have the money to do this on my own.

I would prefer to have another advocate or staff member that came with me. One other thing to think about is getting music equipment or technology that allows music artists.

Like mean to express themselves and maybe and be fun to be a part of profession professional classes for musicians.

So she was actually sharing that on behalf of another advocate. So. Thanks for that, I think we have Vicki who has something to say as well.

Yes, possible resource, organization that is not funded by the DD board or mental health board is CCAMR and they give mini-grants.

Okay.

Directly to people with disabilities up to \$2,000 per year for just those kinds of things. Now that the person may need support in writing a proposal for that, but they're pretty open to anything.

That really is something that would improve your quality of life.

. So

What is that? CCAMR.

That was that was an organization which existed for a couple of decades here to run a small group home. And then the you know the economics of the small group home.

How do people know about this?

Can I add something to that? You can be added to an email list for that too, and so you get, you can get notifications for that.

And I mean what we did is then sent it to all of the different programs so that they could ask people what they were interested in and help them complete the application.

It's hard for us to figure out what the county knows. But can that information be more available and easy to understand?

Making areas more walkable and accessible like the sidewalks.

I would say outreach to rural parts of the county and fund services and supports that benefit those in those areas.

More mental health and specific mental health professionals that know how to support people with intellectual or developmental disabilities.

00:54:51.405 --> 00:54:58.198

I'm aware that the DD board can advocate to the county board if we have anything we'd like to share.

I thought about how useful it would be to have something somewhere to the subway system in Chicago where I'm from.

00:55:06.008 --> 00:55:12.347

I'm unsure what that would look like for our cities, but I know it was an asset to some people who use it.

And other cities. Also, I'd like the County Board to know how important it is for our community to be accessible.

Like having sidewalks with slopes, talking crosswalks. And I'd like to further add

A lot more special computerized aids for the blind.

In other words, more technology for the blind, for the visually impaired, who have a difficult time getting around.

I think those are, you know, great ideas. I know for the accessibility and making areas more walkable.

00:56:00.169 --> 00:56:14.190

We would be advocating to, usually like the City, so like the City of Champaign, City of Urbana.

So I mean, that's definitely something that can be done. I know it. Or like City Champaign I usually it usually comes up I think or probably like Garden Hills and other areas that aren't as sidewalk-friendly unfortunately.

You know, I think definitely some of these things can be presented to the County Board as well.

00:56:35.188 --> 00:56:38.762

I know we have a County Board member on our board. Did they have one on the DDB? It's a liaison position.

It's a little bit different, but they communicate.

If I hi County Board member here. One thing that I'm hearing over and over again is that,

The transportation is a big issue and having more transportation would benefit folks with disabilities in our community. And that's definitely something that I can take to the county board.

You know, we work. You know, and fund. The mtd and pair transit and other you know Programs like that, so that's definitely something that I can say, you know, that I can advocate for on our county board.

Another thing that I heard is that, that housing is an issue, and affording housing and affording food and affording those basic things is an issue when you're on Social Security Disability and it absolutely is I can say that for my day job that's something that I deal with all the time and the county board does help to fund

00:57:55.326 --> 00:58:08.036

Some of the programs. Like with utility assistance and with rental assistance and we've we've you know, we've been talking about that and working on that as far as the the ARPA money goes that was mentioned earlier.

00:58:08.036 --> 00:58:16.150

And I just want to put out there that other parts of the government like Cunningham Township like City of Champaign Township and the Regional Planning Commission have rental assistance

00:58:16.150 --> 00:58:28.226

That's like a one-time thing but there are also the subsidized housing opportunities for folks with disabilities.

00:58:28.226 --> 00:58:43.417

And most of those entities can kind of lead you towards those if those are something that would be helpful.

We have the University of Illinois down here. What are they doing? I know I and I always bring up the University of Illinois.

But I mean, I think the Applied Health Sciences department, looking at things like sidewalks and things like that.

That is something that hopefully is a governmental agency we can talk to the University of Illinois and see if we can, there's some collaborative work that can be done.

Because it's we're still part they're still part of our community, and also I know Tobie brought up a rural community, and I think we a lot of times we just concentrate on Champaign-Urbana and forget that Champaign County has

A rural community. I mean, Philo and Tolono and parts of Mahomet and Seymour and things like that are places where transportation isn't available.

So, yes, we can hopefully encourage the University of Illinois and other governmental bodies to find some funding for it.

I also wanted to piggyback on that idea about the university because one thing I heard - this is more going back a little bit - but I've heard over and over from you all is this idea of

Being able to attend events being part of activities, it's so important to being, to feeling a part of the community and that sense of belonging that I think has been mentioned and alluded to and the University of Illinois I know, having worked there in the past and being an alum myself,

Does have a lot of these events. A lot of what the sort of fun activities and interesting things in the community are brought in by the University.

So I do wonder kind of similarly, if there are ways to partner with the University to make those things accessible to you all.

I also was thinking about some of the the comments about like getting involved with music and expressive arts and I know that some of the, there's a few programs the mental health board funds for sort of other populations that I wonder if we might, there could be ideas taken from that around the like expressive arts and creativity that might be

Able to, might be interesting for you all and that you might want to, that we could maybe, help partner to fund in the future.

Was she doing anything with Parkland, not just.

So I had a quick comment and a question. A kind of a comment, kind of a comment and a question at the same time.

So, the, so I'm gonna see you at home, so this isn't necessarily from my work experience, but

From a friend that I have that has disabilities, he has a personal assistant through DRS, but that personal assistant cannot provide transportation to him.

And I'm a little fuzzy as to the details why I think maybe it has something to do with Medicaid, but I could be wrong. Like I said this is just kind of from my experience with a friend,

01:02:12.031 --> 01:02:30.013

But he, for example, cannot go to the store himself. He can send his personal assistant with a list of things to get for him from the store, but he himself cannot go shopping

01:02:30.013 --> 01:02:37.284

Because the personal assistant can't transport him and I think if something like that could change that would be amazing and I don't know how that gets done, but I don't know why a personal assistant couldn't give rides to the doctor, rides to the store, those kind of things.

I think that has - you could call, they would have to deal with the PSW, the personal support worker versus the personal assistant.

You need to call and say it has to do with that issue. Maybe he needs to apply for a personal support worker and stuff and personal assistant and you'll have to go through all they can tell you.
