July 19, 2011 Springfield, IL - Recorders from across the State of Illinois announced today their willingness to assist in an ongoing investigation by the Attorney General's office against "Robosigning." In a press release dated May 26, 2011, Attorney General Lisa Madigan announced her effort in the ongoing probe into the alleged fraudulent practices used by institutions that contributed to the collapse of the U.S housing market and the subsequent global financial crisis. With the Attorney General's investigation, Recorders throughout the State have taken notice and are cooperating in anyway they can. These alleged fraudulent schemes may not only jeopardize the land recordation system but may damage an individual's property rights and it is the responsibility, as Recorders, to protect the integrity of the land recordation system within our counties.
