SUMMARY: ON 7/3/2021 AT APPROXIMATELY 2058 HOURS, CHAMPAIGN COUNTY SHERIFF DEPUTIES, LUDLOW FIRE, AND OSF PRO AMBULANCE RESPONDED TO A REPORT OF AN ACCIDENT WITH INJURIES IN LUDLOW TOWNSHIP. UPON ARRIVAL, WE LEARNED THERE WERE TWO VEHICLES THAT COLLIDED HEAD-ON AFTER ONE VEHICLE SWERVED DUE TO AN ANIMAL CROSSING THE ROAD. THE DRIVER AND PASSENGER OF UNIT TWO WERE TRANSPORTED TO AN AREA HOSPITAL FOR TREATMENT. THE UNIT ONE PASSENGER REFUSED MEDICAL ASSISTANCE ON SCENE AND WAS RELEASED. THE DRIVER OF UNIT ONE INITIALLY REFUSED MEDICAL ASSISTANCE AND WAS LATER TRANSPORTED TO AN AREA HOSPITAL WHERE HE SUCCUMBED TO HIS INJURIES. BOTH VEHICLES INVOLVED WERE TOTALED. IT WAS LATER LEARNED THAT UNIT ONE WAS BEING DRIVEN WITHOUT PERMISSION AND WAS LATER REPORTED STOLEN BY THE OWNERS OUT OF IROQUOIS COUNTY.
