Sheriff asked for the commission's approval of the list. Commissioner Anderson made a motion to certify the applicants for the position of sergeant; Commissioner Clark seconded. Motion passed. The list will be current through July 10, 2019.

Sheriff asked about the commissioners participating in oral interviews, he advised that it would be a problem if not all attended. Commissioner Clark would like to sit in on oral interviews. Sheriff Walsh said if we invited informally, there should not be a problem with just one commissioner attending.
