During this incident, deputies arrived and spoke with both parties involved. Following an interview with the involved parties, deputies found that the male and female involved had both been physical with each other that evening. However, the male-half and husband was found to have been the primary aggressor. That male was later placed under arrest for domestic battery and transported to the Champaign County Satellite Jail for his offense.
