**CALL TO ORDER**

Chair Rector called the meeting to order at 4:00 p.m. Declaring a quorum present, the Chair proceeded with the meeting.

**APPROVAL OF MINUTES**

Commissioner Adair made a motion to approve the minutes from the January 18, 2013 meeting. Seconded by Commissioner Anderson. Motion passed.

**PUBLIC PARTICIPATION**

Sheriff Walsh checked the lobby of the Sheriff's Office - there was no public participation.

**DISCUSSION**

Sheriff Walsh spoke to the Commission about the Corrections Lieutenant/Sergeant eligibility list. He assured the Commission that Teresa made sure all individuals were eligible for the position they were being certified and requested the Commission take action and certify the list (attached). Commissioner Anderson made a motion to certify the Lieutenant/Sergeant list for the Correctional Division. Seconded by Commissioner Adair. Motion passed.

**OTHER BUSINESS**

Chair Rector advised the commission we needed to have a re-election of officers due to Kelly Griffith resigning and Sami Anderson being appointed to the Commission. He said he would like to continue on as Chair. Chair Rector spoke to Commissioners about the Vice-Chair and Secretary positions. A motion was made by Chair Rector for Mr. Rector to continue on as Chair; Mr. Adair would be appointed Vice Chair and Ms. Anderson would be appointed as Secretary of the Commission, seconded by Commission Adair. Motion passed.

Sheriff spoke to the Commission about the disciplinary binders and also recent/upcoming changes at CCSO. Due to discipline, Lt. Michael Johnson of the jail was demoted to a Sergeant position (with consent), Lt Greg Mills chose on his own to be demoted to Sergeant due to wanting to continue his education. Lieutenant Ed Ogle and Chief Deputy Kris Bolt will both be retiring late summer/early fall – Sheriff Walsh advised the Commission he does anticipate promotions/movement in the Law Enforcement Division.

**ADJOURNMENT**

Motion to adjourn the meeting by Commissioner Anderson; seconded by Commissioner Adair. The meeting adjourned at 4:10 p.m.




