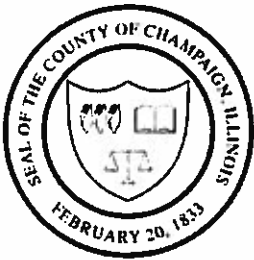

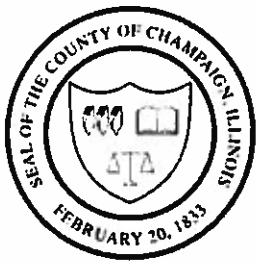
Health alliance Medical Plan Update and Review

John Malachowski provided a handout comparing the last three years of claims. According to the report, Health Alliance paid out approximately \$1.5 million dollars more in claims than it did in premiums. He stated that to be the reason for Health Alliance's initial request for a 51% increase last year; due to the fact the previous year's loss was \$2.2 million dollars.

The committee talked about the uncertainty with regard to the Affordable Care Act and what may happen in the next few months. Mr. Malachowski informed the committee Gallagher expects a 45 – 55% premium increase in the market.

Dissemination of Information to All Employees

The committee discussed options for managing the flow of information to the entire employee population. Ms. Heiser commented that only 58% of eligible County employees attended the mandatory open enrollment meetings. She also noted the presentation is available online for those who are looking for additional information. The consensus is that there will be premium increases for 2018. Mr. King suggested creating a comparison of the County plan and plans available in the marketplace.
