




2006 Number of Animals Registered










Cats Transferred





Dogs Transferred










2006 Calls for Service in Villages



2006 Bite Breakdown by Village/City






2006 Age of Victims of Dog Bites

Children: Under 18 years of age






2006 Age of Victims of Cat Bites






2006 Breakdown of Dog bites by Sex of Animal






2006 Breakdown of Cat Bites by Sex of Animal






Number of Dogs/Cats Vaccinated at Time of Bite




