Tuesday, June 11, 2019

Call to Order

The Champaign County Board of Health held a meeting on June 11, 2019 at the Champaign-Urbana Public Health District office, 201 W. Kenyon Road, Champaign. The meeting was called to order at 5:37 PM by President, Dr. Krista Jones.

Roll Call

Upon roll call, the following Board members were found to be present: Dr. Krista Jones, President, Dr. Julie Kumar, Vice President, Dr. John Peterson, Secretary/Treasurer, Dr. Kyle Fleming, Mr. David King, and Dr. Dorothy Vura-Weis. Mr. Bradley Clemmons, County Board Liaison and Mr. David Thies were absent.

Also present were: Ms. Julie Pryde, CUPHD Administrator, Mr. Jim Roberts, CUPHD Director of Environmental Health, Whitney Greger, Program Coordinator, and Michael Flanagan, Environment Health Program Coordinator.

Approval of Agenda/Addendum

Mr. Dave King made a motion to approve the agenda. Dr. Dottie Vura-Weis seconded the motion. With all in favor, the motion carried.

Approval of Minutes

Dr. Vura-Weis made a motion to approve meeting minutes from November 27, 2018. Mr. King seconded the motion. With all in favor, the motion carried.

Correspondence and Communications

Ms. Julie Pryde reported the Summer Food Program, at Champaign-Urbana Public Health District and local satellite locations, is feeding over 500 kids a day. This is a significant, noticeable increase from last year.

SmileHealthy

Dr. John Peterson made a motion to receive and place on file the October 2018, November 2018, December 2018, January 2019, February 2019, March 2019, and April 2019 SmileHealthy monthly reports. Dr. Kyle Fleming seconded the motion. With all in favor, the motion carried.

CUPHD

Dr. John Peterson made a motion to approve the CUPHD invoices for October 2018, November 2018, December 2018, January 2019, February 2019, and March 2019. Mr. Dave King seconded the motion. With all in favor, the motion carried.

Presentation by Teresa Radosevich, MPH, Posting of Food Safety Inspection Notices in Champaign County.

Based upon the Board's discussion, moving forward, the Board plans to show the presentation, Posting of Food Safety Inspection Notices in Champaign County, to the Committee of the Whole. It is the Board's hope to determine what the Champaign County Board members might perceive as barriers to passing the ordinance.

Discussion took place regarding the proposal that the Village of Royal has put forth for a small community septic system to serve the seven downtown businesses. This is needed due to a space limitation on the properties of these establishments. A legal system that meets 2019 code is required for future growth.

Mr. Dave King made a motion to approve a Letter of Support for the Village of Royal to seek grants for the community septic system. Dr. Julie Kumar seconded the motion. With all in favor, the motion carried.

Dr. Kyle Fleming made a motion to waive septic permit and variance fees associated with the small community septic system in Royal, Illinois. Dr. Dottie Vura-Weis seconded the motion. With all in favor, the motion carried.

Mr. Dave King made a motion to approve the issuance of variances for surface discharging aeration (NSF 40) systems for homeowners with failing septic systems where no other option is economically feasible without an NPDES permit from IEPA. Dr. Julie Kumar seconded the motion. With all in favor, the motion carried.

Dr. Kyle Fleming made a motion to place on file the CUPHD Reportable Diseases and Performance Management reports. Dr. Julie Kumar seconded the motion. With all in favor, the motion carried. Dr. Dottie Vura-Weis asked Ms. Julie Pryde to look into the graphs and reports posted and make sure they are lining up.

Dr. John Peterson asked Ms. Julie Pryde for an update on measles. Ms. Pryde reported we had many people in quarantine with measles; however, the measles outbreak is officially over. She also reported that there are zero cases of mumps at this time and that CUPHD is currently having an issue with a local provider who is not reporting chicken pox. She reported that CUPHD can't confirm whether or not there is an active chicken pox outbreak at this time.
