6 **Call to Order**

8 The Champaign County Board of Health held an electronic meeting via Zoom on  
9 April 27, 2020. The meeting was called to order at 5:35 PM by President, Dr. Krista  
10 Jones.

23 Dr. Dottie Vura-Weis made a motion to approve the agenda. Mr. David Thies

30 **Correspondence and Communications**

32 Ms. Julie Pryde gave an update on COVID-19. Champaign County currently has  
33 109 cases, 22 active cases, five hospitalizations, and six deaths. Twenty-four of the  
34 total cases are in the County due to an outbreak at a local pork plant. The employees  
35 from that plant are currently being tested for COVID-19.

37 Additional comments included that a long-term care facility has a positive case  
38 and that testing efforts are increasing. A brief discussion was held regarding antibody  
39 testing.

41 Dr. Krista Jones provided an update that the Champaign County Board did not  
42 approve the full fund balance budget amendment. The County approved a total  
43 allotment of \$260,000.

45 A brief discussion was also held regarding the jails. Ms. Pryde discussed protocol  
46 and changes that have been implemented. The organizer of the Champaign County  
47 Bailout Coalition reached out to the Champaign County Board of Health members  
48 inquiring about plans for the jail during COVID-19. Dr. Dottie Vura-Weis responded on  
49 her own behalf.
