RESOLUTION ESTABLISHING THE CHAMPAIGN COUNTY LOCAL FOODS POLICY COUNCIL

WHEREAS, the Champaign County Board has adopted Resolution No. 4872 establishing and endorsing a Champaign County Economic Development Policy; and

WHEREAS, the Champaign County Economic Development Policy states as Goal ED-4 the following: Preserve the strength of agriculture and agritourism, and the existing business base, while diversifying the local economy through objectives of:

- Promote the growth of agriculture and agritourism that is both sustainable and profitable;
- Encourage development of enterprises that add value to local agricultural production;
- Encourage development of appropriate non-farm enterprises that augment income for farm families; and

WHEREAS, the Champaign County Board recognizes the establishment of a Local Foods Policy Council to encourage the establishment of small businesses; to encourage the offering of better and fresher food available locally; to encourage larger institutional entities to commit to the use of 10% of local food to support growth and the local economy; to encourage the efficient use of land, and preservation and conservation of agriculture; to encourage reduction in food transportation; and to promote educational resources for the local population, achieves the Champaign County Economic Development Policy Goal ED-4 and subsequent objectives;

The purpose of this memorandum is to explain the rationale and need for Budget Amendment #12-00013.

This amendment is being submitted to increase the appropriation of the Contributions and Grants line item (533.92) by \$500,000 in order to implement specific program components necessary to operationalize a system of care for youth with serious emotional disturbance (SED) and multisystem involvement.

The revenue to support this amendment includes \$433,306 received in FY2010 and FY2011 along with \$66,694 of grant funding which will be received during FY2012.

The spending and implementation plan for this revenue is being developed in collaboration with the Illinois Department of Human Services (IDHS) and the Federal Substance Abuse and Mental Health Services Administration (SAMHSA). The plan will also be reviewed and approved by the Champaign County Mental Health Board (CCMHB) consistent with their statutory authority.

AUTHORIZATION FOR LOAN TO THE GENERAL CORPORATE FUND FROM THE PUBLIC SAFETY SALES TAX FUND

WHEREAS, The General Corporate Fund may need a loan of up to \$1,500,000 for a period not to exceed twelve months to cover cash shortfalls; and

WHEREAS, The Public Safety Sales Tax Fund has adequate reserves to make this short-term loan; and

WHEREAS, The loan can be traced to public safety expenditures for the period of the loan, including but not limited to, salaries and operating expenses for the offices of the Sheriff and the State's Attorney; and

WHEREAS, The FY2012 tax levy for the General Corporate Fund is \$7,876,733 and there are no outstanding tax anticipation warrants or notes;

NOW, THEREFORE, BE IT RESOLVED That pursuant to 55 ILCS 5/5-1006.5, 55 ILCS 5/5-1016, 55 ILCS 5/5-10014, and the authority recognized in <u>Gates V. Sweiter</u>, 347 Ill. 353, 179 NE 837 (1932), the Champaign County Board approves a loan of up to \$1,500,000 from the Public Safety Sales Tax Fund to the General Corporate Fund for a period not to exceed twelve months; and

BE IT FURTHER RESOLVED That the County Auditor and County Treasurer are hereby authorized and requested to advance the above sum and to repay this advance within twelve months from the General Corporate Fund.

RESOLUTION IN RECOGNITION OF THE ESTABLISHMENT OF THE CHAMPAIGN COUNTY VETERANS ASSISTANCE COMMISSION

WHEREAS, the Champaign County Board has been presented with the Constitution and By-Laws of the Veterans Assistance Commission of Champaign County as adopted and approved by said Commission on February 24, 2012; and

WHEREAS, the County Board recognizes its responsibility to the Champaign County Veterans Assistance Commission as documented in 330 ILCS 45/9 to include the following:

- The Commission superintendent and the chairman of the County Board shall have general oversight
 of the distribution of all moneys and supplies appropriated by the County for the benefit of military
 veterans and their families, subject to such rules, regulations, administrative procedures or audit
 reviews as are necessary as approved by the County Board to carry out the spirit and intent of this
 Act; (330 ILCS 45/9)
- The County Board shall, in any county where a Veterans Assistance Commission is organized, in
 addition to sums appropriated for assistance and emergency assistance purposes under this Act,
 appropriate such additional sums, upon recommendation of the Veterans Assistance Commission
 and as approved by the County Board, to properly compensate the officers and employees required
 to administer such assistance; (330 ILCS 45/10)

NOW, THEREFORE BE IT RESOLVED by the County Board of Champaign County that it acknowledges and accepts the Constitution and By-Laws of the Veterans Assistance Commission of Champaign County as documented in Attachment A of this Resolution; and

BE IT FURTHER RESOLVED by the County Board of Champaign County, that in recognition of the establishment of the Champaign County Veterans Assistance Commission, the County Board shall develop a staffing plan and budget for the Champaign County Veterans Assistance Commission, in accordance with the County Board's statutory authority and taking into consideration the staffing plan and budget that has been presented and recommended by the Champaign County Veterans Assistance Commission, with final adoption of said staffing plan and budget subject to the approval of the Champaign County Board.

CONSTITUTION and BYLAWS of VETERANS ASSISTANCE COMMISSION of CHAMPAIGN COUNTY

ARTICLE 1 - NAME

Section 1. The name of this commission shall be "Veterans Assistance Commission of Champaign County".

ARTICLE II - PURPOSE

- Section 1. The purpose of this Commission is to promote the welfare of honorably discharged veterans of military service and their families.
- Section 2. To act as a central service office for all veteran organizations included as members of this Commission.
- Section 3. To handle all government claims work referred to the Commission by member organizations.
- Section 4. To have general oversight of the distribution of all relief and supplies that may be appropriated for the benefit of veterans and their families.
- Section 5. To formulate such rules and regulations in the Commission that will enable it to carry out the purposed above set forth.

ARTICLE III – JURISDICTION

Section 1. The territory to be included within the jurisdiction of this commission shall be the entire County of Champaign, Illinois.

ARTICLE IV - OFFICE

Section 1. The headquarters and principle office of this Commission shall be provided by Champaign County.

ARTICLE V - MEMBERSHIP

Section 1. The membership to this Commission shall be composed of one delegate and one alternate from any Unit, Post, Camp, or Chapter of any recognized Veterans Organization interested in the object and purpose of this Commission. The Veterans Organization must qualify under the Illinois Compiled Statutes, subject to rules and regulations governing admission, and may apply to become active members. All Units, Posts, Camps, or Charters of recognized veterans organizations requesting membership in this Commission must have an office, headquarters, post home or other official domicile located within the geographic limits of Champaign County.

Section 2. Each delegate and alternate must be an Honorably Discharged veteran of the United States Armed Forces and a resident of Champaign County. All delegates and alternates shall be certified in writing and signed by the presiding officers of their respective Unit, Post, Camp, or Chapter, prior to the next regularly scheduled meeting, the date to be herein designated.

Section 3. Each organization and delegate is entitled to one vote, which may be cast only if the delegate or alternate is present.

Section 4. No one delegate or alternate shall be permitted to vote for any organization other than the one they officially represent. No delegate or alternate may represent more than one veteran organization.

ARTICLE VI - OFFICERS

Section 1. Elected Officers of this Commission shall be President, Vice President, Treasurer, Secretary, Judge Advocate and other officers deemed necessary by the Commission.

Section 2. All officers shall be elected at the annual meeting in the month of November, and all officers so elected shall be installed and assume their duties at the next regular meeting following their election and shall continue in the office for one year until their successors are regularly elected and installed.

Section 3. Any member of this Commission shall be eligible to hold a Commission office.

Section 4. Vacancies in any office occurring during the year shall be filled by the members of this Commission. A vacancy shall exist when an Officer is absent from regular meetings of said Commission for a period of time considered detrimental to the interest of said Commission provided that no vacancy shall be deemed to exist unless said Officer shall have been absent for not less than three consecutive meetings. Election to fill vacancies shall occur at the meeting following the vacancy notice to the Commission.

ARTICLE VII – EXECUTIVE COMMITTEE

Section 1. An Executive Committee, consisting of the elected officers and two (2) other delegates elected by the Commission members.

Section 2. The Executive Committee shall direct the work of the Commission in the interim between the regular meetings of the Commission. The Executive Committee shall decide matters of policy and action to be taken in emergencies arising between meetings.

Section 3. A quorum of the Executive Committee shall consist of at least three members.

ARTICLE VIII - COMMITTEES

Section 1. There shall be an Executive Committee, which shall be composed of seven members of this Commission, including the President, Vice President, Treasurer, Secretary, Judge Advocate, and two at-large delegates. The Superintendent shall hold ex-officio status.

Section 2. The President shall, within the consent of the membership, appoint a Grievance Committee, to which a veteran may appeal for satisfaction if he/she feels that any injustice has been done to him/her by the Superintendent of this Commission, either with reference to service of relief. This Committee shall consist of one member each of the major veterans' organizations presented by this Commission.

ARTICLE IX - MEETINGS

- Section 1. The regular meeting of this Commission shall be held on the first Saturday of each month at the hour of 2:30pm. Location of the meeting shall rotate between Units, Posts, Camps and Charters and shall transact such business as may be properly brought before it.
- Section 2. The regular meeting of this Commission held in the month of November of each year shall be the annual meeting, at which time all officers of this Commission shall be elected.
- Section 3. Special meetings may be called by the President or two other members of this Commission and the Secretary shall give notice of such meetings by mailing a copy of the notice to all members of the Commission at least three days prior to the date of said meeting, and no other business then that for which it is called shall be transacted.
- Section 4. Procedures at all business meetings shall be governed by Robert's Rules of Order, except as herein otherwise provided or amended.
- Section 5. Seven Commission members from different veterans organizations constitute a quorum to transact all business at any regular, special or emergency meeting, provided three of those members are elected Executive Board Members.

ARTICLE X - SUPERINTENDENT

- Section 1. The executive powers of this Commission shall be vested in the Superintendent, who shall be elected by the Commission to serve at the pleasure of the Executive Committee.
- Section 2. The Superintendent of the Veterans' Assistance Commission shall appoint a Secretary to assist him/her in the duties of the office, if required, subject to the approval of the Commission and the Champaign County Board.
- Section 3. Neither the Superintendent nor the secretary shall be allowed to hold any political or public office during their term of service to the Commission.

Section 4. The office shall be provided, furnished and equipped by Champaign county, with all necessary supplies needed by the Superintendent for carrying out his/her purpose. The supplies shall be in the Superintendent's charge.

Section 5. This office shall be conducted in the interest of and for the service to military veterans and their families and survivors who need assistance and for the rendering of such services as may be considered reasonable for carrying out the purpose of this Commission.

Section 6. The office shall be under the direction of the Superintendent further designated as Superintendent of Veterans Assistance commission of Champaign County, who shall investigate and report to the proper County or Governmental agencies and the Veterans Assistance Commission all claims for assistance under the law, and his/her decision shall be final unless in accordance with proper appeal procedures.

Section 7. The Superintendent and any employee may be bonded in the amount recommended by the Commission.

Section 8. The Superintendent shall receive annual salary in the amount recommended by this Commission and approved by the Champaign County Board, and the office staff also shall be properly compensated, in order to be able to carry out the intent of this Commission.

Section 9. The Superintendent shall select, in as far as possible, a secretary from among Honorably Discharged veterans of the United States Armed Forces. If the position cannot be filled by a veteran, a member of the immediate family of a veteran can be selected.

ARTICLE XI - AMENDMENTS

Section 1. These By-Laws may be amended at any regular meeting by a two-thirds vote of the membership attending a regular meeting, provided the proposed amendment shall be given to all members of the Commission at least five (5) days in advance of the date when such amendment is to be acted upon, notifying said members that such a proposal to amend the by-laws is to be voted upon.

Section 2. Any changes or amendments of the existing law, pertaining to the Veterans Assistance commission, by the Legislature or by the ruling of the Attorney General of the State of Illinois, which shall affect or conflict with any provision herein, shall be deemed an amendment to these by-laws.
