**Requested Action:** Approve the Resolution Authorizing Execution and Amendment of Section 5311 Grant Agreement, Public Transportation Applicant Ordinance, and Acceptance of Special Warranty as part of the Federal and State grant applications for Fiscal Year 2023 continued operation of Champaign County Area RuralTransit System (CCARTS).

**Background:** To continue to receive rural public transportation operating funding, Champaign County is required to submit grant applications annually for FTA section 5311 (Rural Public Transportation) and IL Downstate Operating Assistance Program (DOAP). These grants are awarded based on the Illinois Departmentof Transportation's (IDOT) Fiscal Year (July 1, 2022 - June 30, 2023). The separate applications were prepared by RPC staff with input from Champaign-Urbana Mass Transit District staff and will be submitted online.

#### FY21 SECTION 5311 AND DOAP GRANT APPLICATION BUDGET

Allocated federal funding for FY2023 is \$153,871, while the allocated DOAP state funding is \$1,159,400. Total available funding is \$1,313,271; however, the amount of DOAP funding that Champaign County and its operator can obtain will depend on their ability to source local match funding. To be realistic, the FY2023 budget is based on actual expenditures, and the amount of DOAP requested is \$754,390.60. This means the total federal and state request for FY2021 is \$908,261, an overall three percent increase from FY2022.

Coordination has been successful with Piatt County Public Transportation (Piattran) in the past for a few riders who utilize services in Rantoul and other locations in Champaign County. No new service coordination requests have come from Piattran in the past year.

C-CARTS coordinates service in Rantoul to reduce service duplication, such as the transportation provided by the Village of Rantoul Recreation Department. Champaign-Urbana Mass Transit District arranges their deviated fixed route services to align with Rantoul Connector bus stops in the urbanized area, in addition to providing DASH passes to C-CARTS riders with disabilities and persons over the age of 65.

C-CARTS is active in the Region 8 HSTP Technical Committee, as evidenced by providing consistent data and hosting an HSTP meeting in 2019. The HSTP is a unified, locally-derived, comprehensive strategy for delivery of public and specialized transportation services that identifies transportation needs, and specifically those of persons with disabilities, older adults, and persons with low incomes. This plan also identifies strategies for meeting the needs of these transit-dependent groups and prioritizes their service.

Inability to coordinate services with human service agencies in the past largely revolved around the fact that some human service agencies require specific travel needs such as medical transportation certification or a passenger's assistant to be taken back and forth frequently.

Champaign County is assured that the Champaign-Urbana Mass Transit District has the requisite fiscal, managerial, and financial capacity to provide and manage the transportation service as requested by state and federal regulations and funding agreements. MTD has provided fixed-route and complementary paratransit services in the Champaign-Urbana area for over 40 years. Champaign-Urbana Mass Transit District receives direct state and federal funds which require policies, procedures, regulations, reporting, and fiscal management at the same level and some to a greater extent, as the Illinois Department of Transportation. MTD will make their books available to appropriate County officials and auditors at all requested times.

MTD reports all ridership and other performance indicators, such as trip denials and vehicle miles, on a quarterly basis to the PCOM. This information is compiled in a quarterly service report (example attached), and presented to the Rural Transit Advisory Group (RTAG) at each quarterly meeting for comments and questions. Champaign County has a very active and enthusiastic RAG (appointee list attached). They ask questions any time there is a fluctuation in service numbers, which leads to productive conversations about causes and solutions. Regarding the Village of Rantoul service contract, MTD provides ridership numbers on a monthly basis to the Village Administrator. These ridership reports are discussed at the Village Board Meetings. MTD, RPC, and Village of Rantoul staff communicate regularly regarding the service and have already made minor changes since the service began in November 2016.

#### **Public Transit Employee Protections**

#### A. Special Warranty



When federal funds are used to acquire, improve, or operate a mass transit system (public transportation), federal law requires arrangements to protect the interests of mass transit employees (see 49 U.S.C. § 5333(b), formerly Section 13(c) of the Urban Mass Transportation Act). In order to engage the community in local planning activities and initiatives for transit in rural Champaign County,

a formal advisory committee, called the Rural Transit Advisory Group (RTAG), was formed to provide oversight for the federal- and state-funded provision of transportation services within Champaign County, which is operated by MTD through an intergovernmental agreement. The principal responsibilities of RTAG include, but are not limited to: advising transportation providers and the County Board on transportation needs, participating in transportation planning processes, encouraging participation in and use of coordinated transportation services, disseminating information about local transportation services, attending RTAG meetings as scheduled, and developing and presenting an annual report to the County Board. Ridership and performance data provided by CRIS Rural Mass Transit District (former operator of Champaign County rural transportation through September 30th, 2014) and MTD, public comments from the Champaign-Urbana Long Range Transportation Plan committee, and census data, formed the basis for recommendations put forth in the Champaign County Rural Mobility Plan. The plan's recommendations were focused on improving efficiencies, increasing ridership, and decreasing trip denials. Ridership surveys are performed at least once per year to assess performance and identify opportunities for improvement. Champaign County hosted several public meetings regarding route changes before implementation to collect resident input. In January 2014, the Champaign County Rural Mobility Plan was adopted. This plan used 2010 Census data to map the distribution of transit-dependent populations including youth, older adults, persons with disabilities, persons with low-income, and zero-vehicle households. This plan also included statistical data pertaining to ridership, denials, cost per mile, service miles, service hours, and more provided by CRIS Rural Transit (previous operator of Champaign County rural transportation until September 30, 2014). Based on the estimation of need and demand in addition to the availability of existing rural transit services and performance, recommendations for improving rural transit service and efficiency were made. 

- (4) The applicant agrees that the project facilities and equipment shall be used for the provision of mass transportation services within its urban area and that any other use of project facilities and equipment will be incidental to and shall not interfere with the use of such facilities and equipment in mass transportation service to the public.

## CATEGORY 6. TRANSIT ASSET MANAGEMENT PLAN.

*If the applicant owns, operates, or manages capital assets used to provide public transportation, the following certification is required by 49 U.S.C. § 5326(a).* 

The applicant certifies that it is in compliance with 49 CFR Part 625.

## CATEGORY 7. ROLLING STOCK BUY AMERICA REVIEWS AND BUS TESTING.

## 7.1. Rolling Stock Buy America Reviews.

If the applicant will apply for an award to acquire rolling stock for use in revenue service, it must make this certification. This certification is required by 49 CFR § 663.7.

  - (3) Individual presenting a Medicare card issued to that individual under title II or XVIII of the Social Security Act (42 U.S.C. §§ 401 et seq., and 1395 et seq.);
- In carrying out a procurement under 49 U.S.C. § 5307, will comply with 49 U.S.C. (e) §§ 5323 (general provisions) and 5325 (contract requirements);
- Has complied with 49 U.S.C. § 5307(b) (program of projects requirements); (f)

- (g) Has available and will provide the required amounts as provided by 49 U.S.C. § 5307(d) (cost sharing);
- (h) Will comply with 49 U.S.C. §§ 5303 (metropolitan transportation planning) and 5304 (statewide and nonmetropolitan transportation planning);
- (i) Has a locally developed process to solicit and consider public comment before raising a fare or carrying out a major reduction of transportation;
- (j) Either—
  - (1) Will expend for each fiscal year for public transportation security projects, including increased lighting in or adjacent to a public transportation system (including bus stops, subway stations, parking lots, and garages), increased camera surveillance of an area in or adjacent to that system, providing an emergency telephone line to contact law enforcement or security personnel in an area in or adjacent to that system, and any other project intended to increase the security and safety of an existing or planned public transportation system, at least 1 percent of the amount the recipient receives for each fiscal year under 49 U.S.C. § 5336; or
  - (2) Has decided that the expenditure for security projects is not necessary;
- (k) In the case of an applicant for an urbanized area with a population of not fewer than 200,000 individuals, as determined by the Bureau of the Census, will submit an annual report listing projects carried out in the preceding fiscal year under 49 U.S.C. § 5307 for associated transit improvements as defined in 49 U.S.C. § 5302; and
- (1) Will comply with 49 U.S.C. § 5329(d) (public transportation agency safety plan).

#### CATEGORY 9. FORMULA GRANTS FOR RURAL AREAS.

If the applicant will apply for funds made available to it under the Formula Grants for Rural Areas Program (49 U.S.C. § 5311), it must make this certification.   - (2) Category 06 (Transit Asset Management Plan),

- (5) Category 15 (Alcohol and Controlled Substances Testing), and
- (6) Category 17 (Demand Responsive Service).

All applicants must make the certifications in this category.

- (a) Will not dispose of, modify the use of, or change the terms of the real property title or other interest in the site and facilities without permission and instructions from the awarding agency; will record the Federal awarding agency directives; and will include a covenant in the title of real property acquired in whole or in part with Federal assistance funds to assure nondiscrimination during the useful life of the project.
- (b) Will comply with the requirements of the assistance awarding agency with regard to the drafting, review, and approval of construction plans and specifications.

This certification is a material representation of fact upon which reliance was placed when this transaction was made or entered into. Submission of this certification is a prerequisite for making or entering into this transaction imposed by section 1352, title 31, U.S. Code. Any person who fails to file the required certification shall be subject to a civil penalty of not less than \$10,000 and not more than \$100,000 for each such failure.

#### 4.2. Statement for Loan Guarantees and Loan Insurance.

The undersigned states, to the best of his or her knowledge and belief, that:

If any funds have been paid or will be paid to any person for influencing or attempting to influence an officer or employee of any agency, a Member of Congress, an officer or employee of Congress, or an employee of a Member of Congress in connection with this commitment providing for the United States to insure or guarantee a loan, the undersigned shall complete and submit Standard Form-LLL, "Disclosure Form to Report Lobbying," in accordance with its instructions.

Submission of this statement is a prerequisite for making or entering into this transaction imposed by section 1352, title 31, U.S. Code. Any person who fails to file the required statement shall be subject to a civil penalty of not less than \$10,000 and not more than \$100,000 for each such failure.

#### **CATEGORY 5. PRIVATE SECTOR PROTECTIONS.**

If the applicant will apply for funds that it will use to acquire or operate public transportation facilities or equipment, the applicant must make the following certification regarding protections for the private sector.

## 5.1. Charter Service Agreement.

To enforce the provisions of 49 U.S.C. § 5323(d), FTA's charter service regulation requires each applicant seeking assistance from FTA for the purpose of acquiring or operating any public transportation equipment or facilities to make the following Charter Service Agreement. 49 CFR § 604.4.

The applicant agrees that it, and each of its subrecipients, and third party contractors at any level who use FTA-funded vehicles, may provide charter service using equipment or facilities acquired with Federal assistance authorized under the Federal Transit Laws only in compliance with the regulations set out in 49 CFR Part 604, the terms and conditions of which are incorporated herein by reference.

- (1) The applicant agrees that neither it nor any operator of project equipment will engage in school bus operations in competition with private school bus operators except as provided herein.
- (2) The applicant, or any operator of project equipment, agrees to promptly notify the FTA Administrator of any changes in its operations which might jeopardize the continuation of an exemption under § 605.11.
- (3) The applicant agrees that it will not engage in any practice which constitutes a means of avoiding the requirements of this agreement, part 605 of the Federal Transit Administration regulations or section 164(b) of the Federal-Aid Highway Act of 1973 (49 U.S.C. 1602a(b)).
- (4) The applicant agrees that the project facilities and equipment shall be used for the provision of mass transportation services within its urban area and that any other use of project facilities and equipment will be incidental to and shall not interfere with the use of such facilities and equipment in mass transportation service to the public.

#### CATEGORY 6. TRANSIT ASSET MANAGEMENT PLAN.

If the applicant owns, operates, or manages capital assets used to provide public transportation, the following certification is required by 49 U.S.C. § 5326(a).

The applicant certifies that it is in compliance with 49 CFR Part 625.

#### CATEGORY 7. ROLLING STOCK BUY AMERICA REVIEWS AND BUS TESTING.

#### 7.1. Rolling Stock Buy America Reviews.

If the applicant will apply for an award to acquire rolling stock for use in revenue service, it must make this certification. This certification is required by 49 CFR § 663.7.

- (d) Will ensure that, during non-peak hours for transportation using or involving a facility or equipment of a project financed under this section, a fare that is not more than 50 percent of the peak hour fare will be charged for any—
  - (1) Senior;
  - (2) Individual who, because of illness, injury, age, congenital malfunction, or any other incapacity or temporary or permanent disability (including an individual who is a wheelchair user or has semi-ambulatory capability), cannot use a public transportation service or a public transportation facility effectively without special facilities, planning, or design; and
  - (3) Individual presenting a Medicare card issued to that individual under title II or XVIII of the Social Security Act (42 U.S.C. §§ 401 et seq., and 1395 et seq.);
- (e) In carrying out a procurement under 49 U.S.C. § 5307, will comply with 49 U.S.C.
   §§ 5323 (general provisions) and 5325 (contract requirements);
- (f) Has complied with 49 U.S.C. § 5307(b) (program of projects requirements);

- (g) Has available and will provide the required amounts as provided by 49 U.S.C. § 5307(d) (cost sharing);
- (h) Will comply with 49 U.S.C. §§ 5303 (metropolitan transportation planning) and 5304 (statewide and nonmetropolitan transportation planning);
- (i) Has a locally developed process to solicit and consider public comment before raising a fare or carrying out a major reduction of transportation;
- (j) Either—
  - (1) Will expend for each fiscal year for public transportation security projects, including increased lighting in or adjacent to a public transportation system (including bus stops, subway stations, parking lots, and garages), increased camera surveillance of an area in or adjacent to that system, providing an emergency telephone line to contact law enforcement or security personnel in an area in or adjacent to that system, and any other project intended to increase the security and safety of an existing or planned public transportation system, at least 1 percent of the amount the recipient receives for each fiscal year under 49 U.S.C. § 5336; or
  - (2) Has decided that the expenditure for security projects is not necessary;
- (k) In the case of an applicant for an urbanized area with a population of not fewer than 200,000 individuals, as determined by the Bureau of the Census, will submit an annual report listing projects carried out in the preceding fiscal year under 49 U.S.C. § 5307 for associated transit improvements as defined in 49 U.S.C. § 5302; and

#### CATEGORY 9. FORMULA GRANTS FOR RURAL AREAS.

If the applicant will apply for funds made available to it under the Formula Grants for Rural Areas Program (49 U.S.C. § 5311), it must make this certification. Paragraph (a) of this certification helps FTA make the determinations required by 49 U.S.C. § 5310(b)(2)(C). Paragraph (b) of this certification is required by 49 U.S.C. § 5311(f)(2). ## CATEGORY 11. GRANTS FOR BUSES AND BUS FACILITIES AND LOW OR NO EMISSION VEHICLE DEPLOYMENT GRANT PROGRAMS.

If the applicant is in an urbanized area and will apply for an award under subsection (a) (formula grants), subsection (b) (buses and bus facilities competitive grants), or subsection (c) (low or no emissions grants) of the Grants for Buses and Bus Facilities Program (49 U.S.C. § 5339), the applicant must make the certification in Category 8 for Urbanized Area Formula

  - It will inform FTA promptly if its procurement system does not comply with (3) either of those U.S. DOT regulations.
- (e) It will comply with the Certifications, Assurances, and Agreements in:
  - (1) Category 05.1 and 05.2 (Charter Service Agreement and School Bus Agreement),
  - (2) Category 06 (Transit Asset Management Plan),

- (3) Category 07.1 and 07.2 (Rolling Stock Buy America Reviews and Bus Testing),
- (4) Category 09 (Formula Grants for Rural Areas),
- (5) Category 15 (Alcohol and Controlled Substances Testing), and
- (6) Category 17 (Demand Responsive Service).

Section 1. Champaign County shall hereby provide public transportation within the county or counties limits.

Section 2. The clerk/secretary to the governing board of Champaign County shall file a certified copy of this Ordinance, within sixty days after passage of this ordinance.

Section 3. This Ordinance shall be in full force and effect from and after its passage and approval, as required by law.

Section 4. That the County Executive of the Champaign County Champaign County Board is hereby authorized and directed to execute and file on behalf of Champaign County a Grant Application to the Illinois Department of Transportation.

Section 5. That the County Executive of the Champaign County Champaign County Board is hereby authorized and directed to execute and file on behalf of Champaign County all required Grant Agreements with the Illinois Department of Transportation.



In this context, the term `sex' includes pregnancy, childbirth, or related medical conditions; gender identity; and sexual orientation.

Title VII of the Civil Rights Act of 1964 (Title VII), as amended by the Equal Employment Opportunity Act of 1972 and the Civil Rights Act of 1991, prohibits discrimination on the basis of race, color, religion, national origin, or sex in all institutions with 15 or more employees -- including state and local governments and labor organizations. (42 U.S.C. §§ 2000e et seq.) Title II of the Genetic Information Nondiscrimination Act of 2008 (GINA) applies to private employers and state and local government employers with at least 15 employees, regardless of whether they receive federal financial assistance. It prohibits covered employers from discriminating on the basis of an applicant's or employee's genetic information (such as the results of genetic tests or family medical history), generally prohibits employers from acquiring genetic information of applicants and employees, and requires employers to keep genetic information confidential, with very limited exceptions. The U.S. Equal Employment Opportunity Commission (EEOC) is the enforcement authority for Title VII and provides official interpretation of employment laws that prohibit discrimination as outlined in 29 CFR Part 1600. EEOC enforces not only Title VII and GINA, but also the Equal Pay Act of 1963, the Age Discrimination in Employment Act of 1967, Title I of the Americans with Disabilities Act of 1990, Sections 501 and 505 of the Rehabilitation Act of 1973. FTA defers to the most current regulations and guidance issued by EEOC when making complaint and compliance determinations. EEOC regulations and guidance are incorporated by reference.

The FTA Master Agreement requires all applicants, recipients, subrecipients, and contractors receiving FTA funding to comply with applicable Federal civil rights laws and regulations and to follow applicable Federal guidance. Any FTA applicant, recipient, subrecipient, and contractor who meet both of the following threshold requirements must implement all of the EEO Program elements:

#### 6B. Vehicle Use

IDOT has made some minor changes to this section this year to more closely align with the National transit Database (NTD) definitions. The NTD groups similar services into types of service (TOS) and modes of transit in the database. Agencies report two types of service to NTD: Directly-Operated (DO) and Purchased Transportation (PT).

#### **Types of Service**

**Directly-Operated Services:** Transit agencies classify service as directly operated if they use their own employees to operate the transit vehicles. Agencies that directly operate service typically employ drivers, schedulers, and dispatchers.

**Purchased Transportation:** The NTD defines PT service as service that is provided to a public transit agency or governmental unit from a public or private transportation provider based on a written contract, typically procured via a competitive process. Note: when a recipient passes funds to a lower tier operator, this is a pass-through arrangement and is not Purchased Transportation. In this instance, services and financial data are directly reported by the operator.

#### Service Modes

**Fixed Route:** Fixed route service is a system of transporting individuals in which a vehicle is operated along a prescribed route according to a fixed schedule.

Intercity Bus: Regularly scheduled bus service for the general public that operates with limited stops over fixed routes connecting two or more urban areas not in close proximity, that has the capacity for transporting baggage carried by passengers, and that makes meaningful connections with scheduled intercity bus service to more distant points, if such service is available.

**Commuter Bus:** Fixed-route bus systems that primarily connect outlying areas with a central city. Service typically uses over-th-road buses with service predominantly in one direction during peak periods, limited stops, and routes of extended length. Commuter bus modes typically operate with at least 5 miles of closed-door service between stops. Commuter bus service is considered fixed route, but does not trigger the need for the entity to operate complementary paratransit services.

Flexible Routes: The category includes both route deviation and point deviation services. Route deviation is service that operates along established routes that typically have designated stops. Between these stops vehicles deviate from an established route to pick up or drop off riders within a defined off-route service area. Point deviation services do not follow a specific route. Instead, the drivers stop at bus stops at scheduled times. The buses then travel to the necessary destinations until the next scheduled bus stop.

**Note:** Under some circumstances, route or point deviation service can be operated in a manner that does not require the provision of complementary paratransit services. However, service units are reported as fixed route services for purposes of completing this section.

**Revenue Vehicle Miles (RVM):** For fixed route operations, revenue vehicle miles include the all miles when the vehicle is available for service and there is an expectation of carrying passengers. RVM includes: (a) layover/recovery time. Revenue vehicle miles excludes: (a) deadhead; (b) vehicle maintenance testing; (c) school bus service; and (d) charter service. For demand response service, revenue miles includes all distance from the point of the first passenger pick-up to the last passenger drop-off, as long as the vehicle does not return to the dispatching point.

**Revenue Vehicle Hours (RVH):** For fixed route operations, revenue vehicle miles include the all miles when the vehicle is available for service and there is an expectation of carrying passengers. RVH includes: (a) layover/recovery time. Revenue vehicle hours excludes: (a) deadhead; (b) vehicle maintenance testing; (c) school bus service; and (d) charter service. For demand response service, revenue hours includes all travel time from the point of the first passenger pick-up to the last passenger drop-off, as long as the vehicle does not return to the dispatching point.

Vehicles Operated in Maximum Service (VOMS): VOMS is the number of revenue vehicles an agency operates to meet the annual maximum service requirement. Agencies count their annual VOMS during the peak season of the year on the busiest day that they provide service. In most cases, this is the number of scheduled vehicles because most transit agencies have enough vehicles to operate the scheduled service. VOMS excludes atypical days or one-time special events for non-demand response modes.

#### 6C. Passengers/Fares

**Unlinked Passenger Trips:** UPT is the number of boardings on public transportation vehicles during the fiscal year. Transit agencies must count passengers each time they board vehicles, no matter how many vehicles they use to travel from their origin to their destination. If a transit vehicle changes routes while passengers are onboard (interlining), transit agencies should not recount the passengers. For demand response, transit agencies must include personal care attendants and companions in UPT counts as long as they are not employees of the transit agency. This includes attendants and companions that ride fare free.

#### Fares - Payment

Passenger-paid fares reflect the amount of the fare that the passengers pay on their own behalf. Passenger fares may be paid by the individual or a third party, as defined below:

**Passenger Paid Fares:** All income directly earned from carrying passengers, paid either in cash or through pre-paid tickets, passes, etc. It includes donations from those passengers who donate money on the vehicle, reduced fares paid by passengers in a user-side subsidy arrangement, or payments made through an agreement to provide fare-free service for a certain group, e.g. payments from a university to provide free service to students. It also includes base fare, zone or distance premiums, express service premiums, extra cost transfers, and special transit fares.

**Organization Paid Fares:** Organization-paid fares are paid for by an organization rather than by the passenger. Organization-paid fares also include funds for rides given along special routes for which a beneficiary of the service may guarantee funds. Organization-paid fares may result from agreements between the transit system and an agency or organization that pays a set amount in return for transit service for the persons covered by the agreement.

#### Fares - Type

The transit system is responsible for establishing fares and any discounts. Fare types typically include:

Full Adult Fares: Revenues earned by transporting passengers for the full adult fare.

Senior Citizen Fares: Revenues earned by transporting passengers who pay a special, reduced fare because they are older than a prescribed age limit.

Student Fares: Revenues earned by transporting passengers who pay a special, reduced fare because they are enrolled in an educational institution.

Child Fares: Revenues earned from carrying passengers who pay a special, reduced fare because they are younger than a prescribed age limit.

Fares for Individuals with Disabilities: Revenues earned from carrying passengers who pay a special, reduced fare because they are persons with disabilities.

**Requested Action:** Approve application for Section 5311CARES Act Grant for Fiscal Year 2023 for Champaign County Area Rural Transit System (C-CARTS).

**Background:** In 2020, the Champaign County Board authorized an application for \$579,840 in Section 5311 CARES Act (emergency rural public transportation funding) through FY21 with Resolution #2020-137. On July 17, 2020, CCRPC staff received the federal Section 5311 CARES Act grant agreement for Champaign County's partial execution for the same amount requested and previously approved by the County Board. Subsequently, Champaign County received an allocation of \$466,867 of Section 5311 American Rescue Plan Act (CRSSA/ARP) emergency rural public transportation funds. However, to continue to receive emergency rural public transportation operating funding, like that received from the CARES Act, Champaign County isrequired to submit a CRSSA/ARP grant application for FY22.

While the CRSSA/ARP federal funding is allocated under the same 5311 program that C-CARTS receives annual funding from, the State of Illinois is still requiring rural grantees to complete a separate grant application.

C-CARTS administration intend to use CRSSA/ARP funding to install 10 bus shelters at the mostused C-CARTS's deviated fixed-route stops in Rantoul, Illinois, as well as wireless capabilities for existing on-board camera systems, and vehicle lift repair with panel replacement. No local match is required for CRSSA/ARP funds. Champaign County is requesting \$193,500 of the total \$466,867. The attached application was prepared by RPC staff with input from Champaign-Urbana Mass Transit District and Village of Rantoul staff and will be submitted to IDOT managers via email.

#### **Project Description**

The Champaign County Area Rural Transportation Service (C-CARTS) operates a deviated fixed-route service in Rantoul, Illinois. The service includes more than 30 stops and operates on weekdays from 5 am to 6 pm. Currently, no C-CARTS stops offer shelter for riders. However, feedback from recent outreach efforts strongly indicates that the addition of bus shelters would increase riders' comfort, safety, and overall satisfaction with the C-CARTS deviated fixed-route system.

Using ridership and stop traffic data collected by operators and on-board software, C-CARTS staff determined the top thirteen most-used stops along the C-CARTS deviated fixed-route system. C-CARTS staff seek to use remaining CARES funds to install bus shelters at ten of the top thirteen most-used stops. In addition, C-CARTS staff propose using CARES funds to expand the wireless capabilities of newly-installed on-board camera units.

C-CARTS staff will coordinate and oversee construction of concrete pads and, where necessary, sidewalk extensions at shelter locations. Staff will also determine, with the help of IDOT, whether engineering and/or NEPA studies are required prior to shelter installation. Staff will oversee the installation of the shelters by the selected contractor, Tolar Manufacturing, using a detailed quote and lead time information provided by the contractor. Staff will also closely monitor the shipping and installation of the wireless add-ons for on-board bus camera units, provided by Gatekeeper Systems, Inc. C-CARTS staff will establish a contract with the Village of Rantoul, similar to the contract C-CARTS has with the Champaign-Urbana Mass Transit District regarding C-CARTS's vehicles, to ensure continued maintenance of the shelters beyond the grant expiration date.

All proposed shelter locations are at current C-CARTS deviated fixed-route stops, which have existed for over five years. Three of the proposed locations are currently on private property and, depending on the determination of IDOT and FTA, may need to be moved to public property or made public using an easement prior to shelter construction. If easements or environmental studies are required, C-CARTS staff understand this could significantly increase the total time spent on each shelter installation. In those cases, C-CARTS staff will oversee whichever method is necessary in order to install as many of the ten proposed shelters as possible before the grant expiration. There are no known risks of the wireless camera component of the proposal being significantly delayed.

Once installation of the shelters and wireless units is complete, C-CARTS expect positive benefits for riders, operators, dispatchers, and even potential riders. Bus shelters will increase riders' comfort, safety, and ability to receive pertinent messaging from the operator. Shelters also have the potential to increase C-CARTS's visibility in the community when they are seen by passing drivers, pedestrians and cyclists who may be potential riders. Wireless capability for on-board camera units will enhance safety of all stakeholders and make security review processes faster and easier.

#### **Project Justification**

C-CARTS serves hundreds of riders and provides close to 35,000 trips each year in rural Champaign County. At present, none of C-CARTS's deviated fixed-route stops are sheltered. Bus shelters provide riders with a place to sit, protection from weather, lighting during evening and night hours, and a feeling of safety and security while waiting for their ride. Shelters can also house important information from agencies regarding route maps, detours, holiday service schedules, and other announcements. In addition to shelters being necessary components of a safe, robust, and rider-focused transit network, current and potential C-CARTS riders who have participated in recent community engagement efforts have expressed a strong desire for the introduction of bus shelters at C-CARTS stops.

Adding wireless capability to existing ob-board camera systems will enhance security for riders, operators, and those on sidewalks or roadways that come into contact with C-CARTS vehicles. Wireless units will enable C-CARTS staff to review footage and make determinations regarding safety issues more expeditiously than without wireless capability.

All quotes obtained by C-CARTS staff are recent. Quotes pertaining to shelters were obtained in February of 2022. Cost estimates pertaining to sidewalk extensions and concrete pads are based on costs from a 2021 sidewalk paving project. Quotes for camera wireless units were obtained in December of 2021. Because the project motive is well-researched and backed by up-to-date cost estimates, C-CARTS staff believe this project will not only enhance the safety and efficacy of service, but will also be a responsible use of IDOT and Illinois taxpayer funds.

**Timeline to Completion** (All projects must have a planned completion date of 5/1/2024).

C-CARTS staff have already obtained up-to-date and accurate cost estimates from relevant vendors and contractors for all components of the project. If engineering or NEPA studies are required prior to shelter installation, this will be the first step C-CARTS staff coordinate. Staff will then oversee the paving of the concrete pads and, where necessary, sidewalk extensions. Meanwhile, C-CARTS staff will found the concrete pads and, where necessary, sidewalk extensions. Meanwhile, C-CARTS staff will found the order to shelter installation, according to Tolar Manufacturing, is 16 weeks. Wireless capability for on-board camera units will be installated expeditiously given the availability of Gatekeeper Systems, Inc. delivery staff and C-CARTS maintenance staff.


