## 2. Approval of the Agenda-

## 4. Public Participation-

- a. Executive Summers— Sent DEIA letter in early June with the intention of finding a professional firm to help county find better representation of
  - i. There was a scheduled meeting
  - ii. Been accused of racial discrimination and threatened legal action and "many FOIAs" would be received
  - iii. Labor Chair Rodriguez has been harassed
  - iv. Executive Summers emphasized that he will not abandon the DEIA work. However, he has also stressed the importance of the board making a well-considered decision rather than simply avoiding potential drama.
- b. Angie Patton is here to provide any info on the items on the agenda for the Clerk's office.
- c. Sheriff's office here because of budget resolution

## 5. Announcements/Communications-

Chair Carter delivered a statement addressing concerns regarding email communication and meeting scheduling. She specifically noted concerns with Michelle Jett. She also shared her preference for meetings to take place on Mondays and Tuesdays due to her availability on those days. Additionally, she expressed her intention to vote against the proposal for appointing the auditor, citing

concerns about potential mistreatment of George. Furthermore, she expressed reservations about how the DEIA+ task force is being established. She provided a comprehensive list of potential members for the task force and indicated a desire to discuss additional appointments with board members. She emphasized the need for a longer timeline for these decisions and conveyed a commitment to ongoing communication, expressing a desire for improved collaboration from all team members.

- b. Member Stohr– Carbon Capture and Storage (CCS) involves capture of CO2 gas from making ethanol or burning coal or making fertilizer. There will be four applications for sequestering CO2 beneath the Mahomet Aquifer. One of them will have a petition submitted in mid September. Dr. Stohr has some concerns about whether this will affect the quality of the ground water.
- c. Chair Carter again— will be going to both jails in Kankakee County regarding complaints made by locals with Vice-Chair Jennifer Locke and Member Chris Stohr.
- d. Member Fortado— Orien will be completing the external audit due to the departure of the Deputy Auditor and Auditor Danos facing challenges with logging into the system that has been used for years to conduct the external audit. This situation highlights the significant work issues within the office. Member Fortado will provide the board with details regarding the expenses associated with this external audit.
