I. Welcome and Introductions

Chairman John Dwyer called the meeting to order at 10:34 am and introductions were made.

II. Public Comment

No public comments were offered.

III. Review and approval of minutes from the February 27th, 2018 meeting

V. Trip report from Midwest Emergency Preparedness & Response Conference

Two significant topics discussed at this year's conference were the need for a Multi-Agency Resource Center (MARC) in a disaster and issues associated with the Active Shooter. To date response to a disaster has been focused on emergency response efforts and the immediate needs of victims. Later the focus turns to loans, grants, etc. need to rebuild. What is missing is a method by which victim can begin to reestablish their identity, credit and important papers in an efficient/timely

manner. All of which will be required for the grants/loans process. The MARC is composed of various groups and agencies that can assist: DMV- driver's license, Aid organizations-immediate financial support, local government-property records/deeds. Based on the community and impact will dictate what agencies need to be involved.

The recent shooting events around the nation has identified significant issues pertaining to the health and welfare of employees. First, this violence can occur anywhere, therefore plans are required for functions beyond the workplace. Second, the HR and Employee Assistance Programs must get away from the "policy" of the immediate return to work. Third, if a victim whenever there is another reported incident these people will once again become victims and must have a support mechanism.

VI. Local incidents, training, exercises and upcoming events discussion

Monsanto Decontamination training Thursday 28 June with the Champaign Fire Department HazMat Team for a chemical spill. Copy of Dr. Gilmores "All-Hazards Preparedness for Rural Communities" Emergency Book was given to the Champaign County Farm Bureau. IEMA Summit September 6-8 in Springfield.
