#### Summary

The monthly IEMA, local emergency radio and siren tests were conducted. The EMA liaison group met this month for upcoming events and for community awareness. EMA wasn't able to attend the monthly Fire Chief's Association meeting due UIUC drill preparations and Champaign gas leak; however EMA information was passed on the office's behalf to include pipeline testing awareness, availability of response guides and hazardous materials preparedness efforts. EMA hosted the monthly Public Information Officers meeting. University of Illinois Urbana-Champaign and EMA hosted the annual UIUC and Parkland Evacuation drill. EMA also responded with the mobile command post supporting community partners for Post Office exercise, METRO drill, and City of Champaign Gas leak. EMA hosted the Brookens/East Campus Safety and Security meeting with representatives to discuss the purpose/intent of the committee, emergency plan templates for departments, safety and security concerns.
