**Subject:** EMA July and August Report

Summary

Champaign County Emergency Management Agency (CCEMA) remains focused on the COVID-19 response and recovery. This effort includes public messaging, oversight of the testing site at marketplace mall, and preparing for the potential resurgence in the coming months. This period also included additional focus on assisting the University of Illinois on their reopening and the establishment of their Shield Team.

COVID-19 Response

John Dwyer continues to serve as the Emergency Operations Center (EOC) Manager to support response efforts for Champaign County during the Pandemic. Collin Rector, the Deputy EMA Coordinator, is serving as the Logistics Chief in the EOC, and he is supporting personal protective equipment distribution to first responders and qualified medical centers. **Champaign County has distributed 82,810 pieces of PPE** including N95 respirators, surgical masks, hand sanitizer, gloves, touchless thermometers, and other support items. CCEMA also maintains supervision of the Champaign County Testing Center near Marketplace Mall. **The center has tested 44,400 people** as of August 31<sup>st</sup>, 2020, since officially opening on May 19. The County EOC also established a PPE reserve that is stored at CUPHD in case of emergency. This is a 90 day stock to support first responders and the hospitals in case of resurgence.

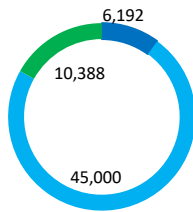
Other Notable Events

- 262 volunteer hours were completed in service of Champaign County EMA in July and August
- Champaign County Search and Rescue held two meetings and a weekend training event
- Coordinator was a guest for the Lions Club Meeting and Exchange Club of Urbana to talk about Emergency Management activities
- Coordinator was featured on a segment on WBGL 91.7 to discuss Emergency Management Agency purpose and activities, and COVID-19 response
- Met with Thomosboro Mayor and emergency management team to assist with their program
- The Deputy Coordinator completed Incident Command System 300 and 400
- Assisted Illini EMS with planning their fall training event with COVID restrictions

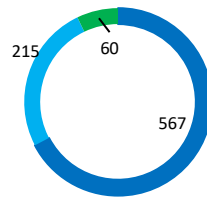
Information Dissemination to Champaign County

CCEMA had **61,580 views** of its social media content and gained an additional **359 followers**.

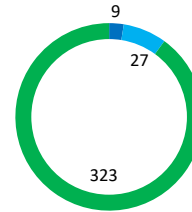
Post Views
