**Subject:** April-May Board Report

Summary

Champaign County Emergency Management Agency (CCEMA) remains focused on the COVID-19 response and recovery with an emphasis on vaccine administration. This effort includes public messaging, oversight of the testing site at Marketplace Mall, and supporting the vaccination clinics. This period included a focus on messaging the importance of vaccines to all residents in Champaign County.

COVID-19 Response

John Dwyer continues to serve as the Emergency Operations Center (EOC) Manager to support response efforts for Champaign County during the Pandemic. Collin Rector, the Deputy EMA Coordinator, is serving as the Logistics Chief in the EOC. **Champaign County has distributed 183,813 pieces of PPE** including N95 respirators, surgical masks, hand sanitizer, gloves, touchless thermometers, and other support items. CCEMA also maintains supervision of the Champaign County Testing Center near Marketplace Mall. **The center tested 146,077 people** as of May 31<sup>st</sup>, 2021, since officially opening on May 19, 2020. The County EOC also established a PPE reserve that is stored at CUPHD in case of emergency. This is a 90-day stock to support first responders and the hospitals in case of resurgence.

Other Notable Events

- 117 volunteer total hours were completed in service of Champaign County EMA in April and May
- Search and Rescue executed a field practice search and certified three new team leaders for operations
- Search and Rescue conducted monthly field training at Middle Fork Forest Preserve
- John Dwyer and Collin Rector attended two Technical Advisory Group Committee meetings through the International Association of Fire Chief's in preparation for the Whole Communities Approach training in Champaign County
- CCEMA responded to the trail derailment in Pesotum and aided the Incident Commander. We utilized E-1 and provided assistance to Canadian National until the site was cleared.

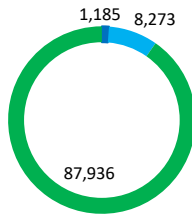
Other Notable Events (Continued)

- John Dwyer led the quarterly Regional Emergency Coordination Group meeting with local attendees

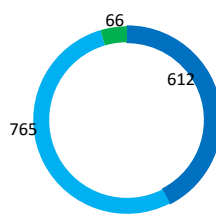
Information Dissemination to Champaign County

CCEMA had **97,394 views** of its social media content and gained an additional **515 followers**.

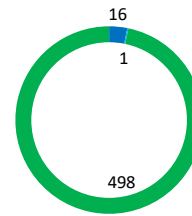
Post Views
