Summary

Champaign County Emergency Management Agency (CCEMA) remains focused on the COVID-19 response and recovery with an emphasis on vaccine administration. This effort includes public messaging, oversight of the testing site at Marketplace Mall, and supporting the vaccination clinics. This period included a focus on messaging the importance of vaccines to all residents in Champaign County.

COVID-19 Response

**Champaign County has distributed over 238,000 pieces of PPE** including N95 respirators, surgical masks, hand sanitizer, gloves, touchless thermometers, and other support items from October-December. CCEMA also provide PPE, linens pillows, and excess cots to Canteen Run and C-U at Home for their services to the local homeless. CCEMA also maintains supervision of the Champaign County Testing Center near Marketplace Mall. **The center tested 179,917 people (18,416 people from October 1<sup>st</sup> to December 31<sup>st</sup>)** as of December 31st, since officially opening on May 19, 2020. The County EOC also established a PPE reserve that is stored at CUPHD in case of emergency. This is a 90-day stock to support first responders and the hospitals in case of resurgence.

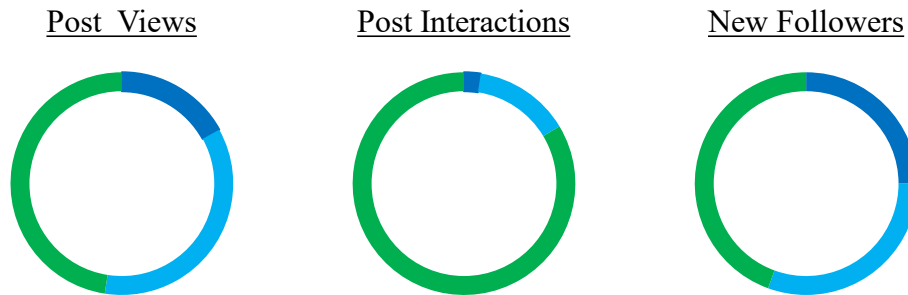
- 205 volunteer total hours were completed in service of Champaign County EMA in Oct-Dec.

- Attended calls with Champaign Economic Development Group throughout the quarter.
- Hosted monthly Search & Rescue training in-person or via zoom.
- Attended IEMA Deputy Director calls on Friday's.
- Updated IL Capability and THIRA Tool (IL-CATT) & Training & Exercise Planning (TEP) Worksheet and submitted to IEMA and received approval to IEMA
- Submitted multiple community events to the NWS for weather support/safety—Oct-Nov.
- Guest speaker for Continuum of Care on Emergency Management Program-Oct 5<sup>th</sup>.
- Hosted Search & Rescue Ground Operations course—Oct 16<sup>th</sup>.

- CCEMA monitored & posted information on several potential severe weather events—Oct 24<sup>th</sup> & Dec 10<sup>th</sup>.
- Participated in annual hazmat exercise with U of I Abbott Power and Champaign Fire Department—Nov 2<sup>nd</sup>.
- Participated in a FEMA cyber virtual table-top exercise-Dec 9<sup>th</sup>.
- Hosted annual community winter weather preparedness meeting via zoom with local NWS office & community partners-Dec 14<sup>th</sup>.
- Attended IEMA webinar on potential cyber threat, Log4J Vulnerability, distributed information to local IT representatives-Dec 14<sup>th</sup>.
- Attended virtual Regional Healthcare Coalition Meeting-Dec 15<sup>th</sup>.
- Met with local Red Cross representative about community disaster & emergency support services-Dec 21<sup>st</sup>.
- Attended People’s Gas workshop in Mahomet with Cornbelt Fire, Sangamon Fire, Piatt Co EMA & Sheriff’s Office--Dec 22<sup>nd</sup>.
