# OnBoard Agreement

THIS AGREEMENT made this 1st day of August, 2022, between ClerkBase, a division of CompBase, Inc., a Rhode Island corporation with a principal place of business at 2220 Plainfield Pike, Cranston, Rhode Island ("ClerkBase"), and Champaign County, a county organized and existing in accordance with the laws of the State of Illinois, with a principal place of business at 1776 East Washington Street, Urbana, IL 61802 ("Licensee").

In consideration of the mutual promises contained below, the parties agree as follows:

## 1. Program Product

ClerkBase will supply a portal to the OnBoard web application for purposes of entering, tracking and reporting on board/commission member information as described in product brochure and listed on our website at <a href="http://www.clerkbase.com/onboard.php">http://www.clerkbase.com/onboard.php</a>, as well as free technical support, in accordance with the terms stated in this Agreement and the End User License Agreement, at the prices and stages stated below.

Data is stored and backed up on AWS servers, using industry standard procedures and security. Any security breach will be disclosed to the licensee. All data resides in Data centers in the United States and is property of the licensee.

In the event we part ways in the future or we go out of business the licensee will receive a copy of all data in a format that can be imported or utilized in some way in a different system.

#### 2. Term/Termination

The initial term of this contract shall be five (5) years, commencing on <u>August 1, 2022</u>. Any subsequent Renewals shall be for a period of twelve (12) months subject to mutual written agreement of the parties and in accordance with the Renewal terms specified herein.

Licensee agrees to pay the annual subscription charge of \$4,999.00 during the initial term of this Agreement as set forth herein. Thereafter, OnBoard's Annual Subscription is automatically renewable for each subsequent year unless notified in writing thirty (30) days prior to the start of a new twelve (12) month term. Either party may cancel this Agreement at any time upon thirty (30) days prior written notice. In the event Licensee terminates the Agreement prior to the end of any term, Licensee shall be responsible for its prorated share of the Annual Subscription up to its notice of termination.
