

**THIRD AMENDMENT TO THE AGREEMENT FOR INMATE HEALTH CARE SERVICES AT CHAMPAIGN COUNTY, IL JUVENILE DETENTION CENTER  
(Effective January 1, 2022)**

This Third Amendment, effective January 1, 2022 (this "Amendment"), to the Agreement for Inmate Health Care Services, dated March 1, 2018 (the "Agreement") is by and between Wellpath LLC ("Wellpath") and Champaign County, IL ("County").

**WHEREAS**, the Parties have determined that it is necessary and in the best interest of Covered Persons to add tele-health psychiatric assessments and medical adjustments; and

**WHEREAS**, the Parties have determined such changes to be cost-neutral; and

**WHEREAS**, the Parties desire to amend the Agreement to memorialize such changes.

**NOW, THEREFORE**, in consideration of the mutual covenants herein contained and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the County and Wellpath agree as follows:

1. **RECITALS.** The Parties hereto incorporate the foregoing recitals as a material portion of this Amendment.
2. **AMENDMENT TO SECTION 2.0 OF THE AGREEMENT.** The Parties agree that Section 2.0 of the Agreement shall be amended by adding the following section 2.0.3.

2.0.3 Wellpath shall make available either a Psychiatrist or Psychiatric Nurse Practitioner available for psychiatric tele-health appointments. Such appointments shall be billed at a on hour minimum, as needed. The rate for the Psychiatrist is \$156.45 per hour, and the rate for the Psychiatric Nurse Practitioner is \$100.00 per hour.

3. **AMENDMENT TO SECTION 9.0 OF THE AGREEMENT.** The Parties agree that the current term will be extended for 1 month, with a new expiration date of May 31, 2022.
4. **AMENDMENT TO EXHIBIT A OF THE AGREEMENT.** The Parties agree that the Staffing Matrix attached hereto as Exhibit A-1 shall replace the previous Staffing Matrix attached to the Agreement as Exhibit A.
5. **SEVERABILITY.** If any terms or provisions of this Amendment or the application thereof to any person or circumstance shall to any extent be invalid or unenforceable, the remainder of this Amendment or the application of such term or provision to person or circumstances other than those as to which it is held invalid or unenforceable shall not be affected thereby and each term and provision of this Amendment shall be valid and enforceable to the fullest extent permitted by law.


6. **DEFINITIONS.** Capitalized terms used but not defined herein shall have the meaning ascribed to them under the Agreement.
7. **REMAINING PROVISIONS.** The remaining provisions of the Agreement not amended by this Amendment shall remain in full force and effect.

**IN WITNESS WHEREOF**, the Parties have caused this Amendment to be executed in their names or their official acts by their respective representatives, each of whom is duly authorized to execute the same.


