#### **APPROVAL OF MINUTES:**

#### **Approval of Claims:**

Draft program summaries were included in the Board packet. Mr. Tracy briefly reviewed each agencies application requests. Agencies were given an opportunity to respond to their program summaries. Board members were given an opportunity to ask agency representatives questions regarding their applications.

### **OLD BUSINESS:**

#### **Disabilities Resource Expo:**

A report from Barb Bressner was included in the Board packet.

#### Anti-Stigma Alliance Event Update:

Mr. Bill Conlin provided a verbal report on upcoming events.

#### **State Budget Overview and Local Impact Update:**

A Briefing Memorandum was included in the Board packet. In September 2008, we cosponsored a public hearing on the state budget, specifically related to budget cuts, slow payment and bad public policy. At that time, we predicted there would be a continuing struggle for mental health, substance abuse and developmental disabilities programs and services, and there were no optimistic signs on the state budget horizon.

Our new Governor's budget confirms our expectations. On the revenue side, the proposed budget calls for a fifty percent (50%) increase in the state income tax, \$837 Million in other taxes, \$2.2 Billion in short-term borrowing, and \$236 Million for state employee furloughs and changes in insurance.

Despite the projected increase in revenue, a huge budget deficit is still anticipated and the Governor suggests additional budget cuts will be made. Out of the total General Revenue Fund (GRF) budget of \$27,853.9 Billion from which cuts can be made, healthcare and education have been designated as "protected." The protected category accounts for \$20,583.9 Billion of the total GRF which leaves only \$7.270 Billion from which cuts can be made.

Included in the "unprotected" \$7,270 Billion is all of the Department of Human Services (\$4,117.7 Billion), Department of Children and Family Services (\$863.2 Million), Public Health (\$154 Million), Department of Corrections (\$1,399.9 Billion), State Police (\$212.6 Million), Department of Revenue (\$158.2 Million), and the rest is used for the General Assembly, judges, constitutional officers, and state parks.

Unfortunately for those of us who care about disabilities services (i.e., mental health, substance abuse, and developmental disabilities), these budgets are unprotected and therefore subject to cuts. For Champaign County, all service providers funded by the CCMHB and CCDDD are essentially on the state's chopping block. Even though this is not much of a surprise, it is still sobering to see it in print.

Due to Federal requirements pertaining to stimulus dollars, Illinois will be required to pay its bills on time. This will definitely help.
