MOTION: Ms. Jordan moved to approve the minutes from the June 16, 2009 Board meeting. Ms. Dill seconded and the motion passed unanimously.

# **Approval of Claims:**

MOTION: Ms. Jordan moved to accept the claims report as presented. Ms. Dill seconded and the motion passed unanimously.

### **NEW BUSINESS:**

### **CCDDB FY10 Budget:**

A Decision Memorandum on the CCDDB Fiscal Year 2010 Budget including a discussion of policy implications of the projected rate of increase was included in the packet. The Champaign County budget anticipates revenue growth of 01.8%, which is significantly lower than had been originally expected.

MOTION: Ms. Jordan moved to approve the Champaign County Developmental Disabilities Board budget for County fiscal year 2010 as specified in the memorandum and attached budget work sheet indentified as agenda item 12.A. Ms. Dill Seconded the motion. A roll call vote was taken and the motion passed unanimously.

## **Anti-Stigma Alliance:**

A Decision Memorandum on the plan for an event in 2010 was included in the Board packet.

MOTION: Ms. Jordan moved to authorize the executive director to commit to working with the Champaign County anti-Stigma Alliance to sponsor an anti-stigma film at the 2010 Roger Ebert Film Festival and a free screening of a film at the Virginia theatre immediately following the conclusion of the festival. Approve up to \$14,000 as the CCDDB share contingent on approval of \$14,000 by the Champaign County Mental Health Board (CCMHB) to fund an equal share. Ms. Dill seconded the motion. A roll call vote was taken and the motion passed unanimously.

# **State Budget Impact Adjustment:**

A Decision Memorandum authorizing program plan changes to minimize negative impact of the state budget on community services was included in the packet.

MOTION: Ms. Jordan moved to approve the state budget impact adjustment authority recommendations delineated in the Decision Memorandum identified as agenda item 12.C. A roll call vote was taken and the motion passed unanimously.
