PUBLIC PARTICIPATION:

Ms. Claudia Lenhoff, executive director of Champaign County Health Care Consumers (CCHCC) spoke regarding the need for public health and mental health collaboration in the community and commended the study session participants for their willingness to have a dialogue. Ms. Lenhoff distributed a flyer titled: *The Medicaid Crisis in Champaign County—Lack of Access to Primary Health Care.*

Mr. Patrick Leary, executive director of Prairie Center Health Systems (PCHS), reminded participants that substance abuse issues should be recognized and included when discussing the mental health of the community.

COMMITTEE OF THE WHOLE STUDY SESSION:

Presentation—Public Health and Mental Health: Collaborating for Healthy Families and Communities:

Dr. Harry Shallcross was hired by the CCMHB/CCDDB to provide consultation on public health and mental health collaboration in Champaign County. On January 17-19, 2006 a series of

meetings were planned with parents and youth at Don Moyer Boys and Girls Club, the Urban League, providers and youth at the Juvenile Detention Center and the Child and Adolescent Local Area Network for the purpose of gleaning information and impressions concerning access, availability and appropriateness of mental health and public health services in our community. Dr. Shallcross will complete a final report, including recommendations, for consideration.

Dr. Harry Shallcross was introduced and led the discussion on collaborating public health and mental health systems. His presentation focused on the following:

The presentation was followed by a question and answer session as well as extensive discussion.
