CALL TO ORDER:

Dr. Townsend, Board President, called the meeting to order at 7:00 p.m.

Roll call was taken and a quorum was present.

CHAMPAIGN COUNTY BOARD FOR CARE AND TREATMENT OF PERSONS WITH A DEVELOPMENTAL DISABILITY (CCDDB) INPUT:

The CCDDB met earlier in the day.

APPROVAL OF MINUTES:

Minutes from the April 1, 2008 Board meeting were included in the packet for review.

MOTION: Dr. Henry moved to approve the minutes from the April 1, 2008 Board meeting. Mr. McClellan seconded the motion. A vote was taken and the motion passed unanimously.

FINANCIAL REPORT:

Acceptance of Claims:

The claims report was included in the Board packet.

MOTION: Ms. Midden moved to accept the claims report as presented. Ms. Dannave seconded the motion. A voice vote was taken and the motion passed.

NEW BUSINESS:

FY09 Funding Decisions:

An FY09 Decision Memorandum was included in the packet. Recommendations from staff were organized into five "Tiers" as a means of prioritizing available dollars. Specifically, they tiers are used to organize applications in order of priority based on decision support criteria match up and a variety of other factors outlined in this memorandum. The following is an explanation of the five tiers and the staff's rationale for making the recommendations.

Tier One: \$298,105

This group includes the highest level of funding prioritization and is closely aligned with CCMHB target populations and decision support criteria. In addition, all child and adolescent contracts including Quarter Cent for Public Safety Juvenile Justice are also classified as part of Tier One. The recommendations for Tier One for this funding decision process are listed below:

Staff recommend that Tier One be funded in its entirety.

Tier Two: \$429,046

This group includes increased investments in high priority programs and new special initiative programs recommended for FY09 funding.

Mental Health Center – Drug Court	\$ 28,000
Family Service – Self Help	\$ 28,928
Community Service Center	\$ 78,118
Frances Nelson Health Center	\$110,000

Staff recommend that Tier Two be funded in its entirety.

Tier Three: \$380,182

This group includes programs and services that are marginally aligned with salient CCMHB criteria and priorities. This group continues to be subject to possible reductions, redirections, and discontinuation for subsequent funding cycles.

Staff recommend that Tier Three be funded in its entirety.

Tier Four: \$518,922

This category is for multiple year contracts for programs and services that have been identified as not likely to manifest substantial changes in programming and/or budget in future funding cycles. Also, several child adolescent programs excluded from this decision process will be formatted as multiple year contracts. Terms and conditions will be consistent with single-year contracts.

Staff recommend that Tier Four be funded in its entirety.

Tier Five: \$282,076

This group includes all programs NOT recommended for funding. If additional resources (i.e., dollars) were available, further consideration would have been given to several proposals. Others did not match up well with decision support criteria and would not have been recommended.

Staff recommend that Tier Five NOT be funded

*** The recommendation to fully fund the Prairie Center Drug Court proposal will require contract negotiation and significant redirection of effort. Agency wide, Prairie Center Health Systems is recommended to receive a 13.5% increase in funding (\$50,836). The combination of new dollars and redirection of effort from the total pool of allocated dollars will be used to fund the Drug Court Program. A specific point of discussion will be how best to use DFI (Donated Funds Initiative) dollars to meet CCMHB and PCHS objectives.

MOTION: Mr. McClellan moved to approve funding as recommended for Tiers One, Two, Three and Four. Ms. Dannave seconded the motion. A roll call vote was taken and all members voted aye. The motion passed unanimously.

MOTION: Ms. Midden moved to deny funding as recommended for Tier Five. Ms. Dannave seconded the motion. A voice vote was taken and the motion passed unanimously.

Dr. Moore stated the CCMHB's allocation requests demonstrated the tremendous need in our community.

CCMHB-CCPHD Project Recommendation:

A Decision Memorandum was included in the Board packet. The CCMHB and the Champaign County Public Health Department (CCPHD) agreed to implement a jointly funded project with each committing \$25,000 to the initiative. The targeted need to be addressed by the jointly funded project was to be either maternal depression or depression in the elderly. Four applications were received. The recommendation of the Project Review Team is to fund the application received from Crisis Nursery in the amount of \$50,000.

MOTION: Dr. Moore moved the CCMHB approve the recommendation of the Project Review Team to fund Crisis Nursery in the amount of \$50,000 with the cost to be divided equally between the CCMHB and the CCPHD for the 2009 program year (7/1/08 - 6/30/09). Dr. Gullerud seconded the motion. A roll call vote was taken and all members voted aye. The motion passed unanimously.
