#### Parenting with Love and Limits (PLL):

A Decision Memorandum was included in the Board packet. Staff recommendation is that the CCMHB should authorize the executive director to enter into contract negotiations with the Savannah Family Institute (SFI) to establish a PLL site in Champaign County.

MOTION: Dr. Gullerud moved to approve the recommendation authorizing Mr. Tracy to negotiate and establish a contract between the CCMHB and the Savannah Family Institute (SFI) to establish a PLL site in Champaign County. The terms and condition of this contract shall be left to the judgment of Mr. Tracy in consultation and with the approval of the officers of the CCMHB. The contract maximum shall not exceed \$150,000 for the initial one-year

term of the contract. Mr. McClellan seconded the motion. A voice vote was taken and all members voted aye. The motion passed unanimously.
