My name is Claudia Lennhoff, and I'm the executive director of Champaign County Healthcare Consumers, and I just wanted to make some announcements about some of the services that we have available in case, you know, there's people paying attention to this
- 17:49:06 meeting. So one of the services that we have available is that we help people apply for disability SSI and SSDI.
- 17:49:14 And one of the, we actually have really strong staff capacity right now. Thanks in large part to the mental health board.
- 17:49:25 We have a full-time staff member who is just dedicated to that. We got some other grant funding that allowed us to hire another person and our staff are working through applications really, really well.
- 17:49:38 And we work with people at their own pace. So I just wanted to mention that. Then I also wanted to mention about resources for low-income seniors.
- 17:49:47 Because we know that a lot of low-income seniors are really underenrolled in programs that can help them financially and that can help provide some stability for them.
- 17:49:59 This also applies for people with disabilities who have Medicare as well. One of the programs is Medicare savings, which can help people with their monthly Medicare premiums, deductibles, and coinsurance costs.

- 17:50:14 And seniors can save over \$5,300 per year in Medicare-related out-of-pocket expenses with that program.
- 17:50:26 People need to have income, a single individual needs to have an income below about. \$1,640 to qualify for that.
- 17:50:34 There is also Medicare Extra Help. Which is a program to help with the cost of Medicare Part D, prescription drug coverage and copays for prescriptions.
- 17:50:44 This program can reduce the monthly prescription plan premiums as well as get rid of deductibles for people and can also help with the cost of actual
- 17:50:57 prescriptions out of pocket and can help people save over \$2,000 a year. And, income qualifications for that are under
- 17:51:06 \$2,000 a month. Then there's also SNAP, which is food stamps, which a lot of people know about, but a lot of seniors do not realize that they can qualify for that,
- 17:51:16 and, that can help a low-income senior save up to about \$9,000 a year and with
- 17:51:26 Maximum monthly benefit of about \$281 for people who are aged 60 and older. So these programs combined, if somebody qualifies for those, can save a person over \$16,000 a year and can help provide more financial stability, food security, access to medications and so on.

- 17:53:28 To afford. You know continuing services has been a real trying time for a lot of agencies and obviously the reduced... in funding and trying to find funding for a lot of.
- 17:53:42 So trying to find funding for a lot of trying to continue funding funding to continue the agents, the programs for the agencies has been really trying for a lot of the agencies so obviously this year we'll be funding a lot of programs that lost funding or this is new funding for them because they lost funding for funding from other places so With that I'll I'll move on

- 17:54:06 to Lynn's comments or... Were there anyone else that wanted to make a comment from the agencies before?
- 17:54:14 We can hear them now and I don't see any. Okay. Thank you. I have like I have sort of a an odd blend of comments and I'll try to go through them quickly.

- 17:57:21 There's some extra language that doesn't make sense. Thank you so much. And that is also included in my, the memo that I can show as we go through the meeting.
- 17:57:31 But the really big news is that I was I want to present you all with initial budgets next month.
- 17:57:40 It is way ahead of everybody else doing budgets. But you know, so the numbers I'm working with are the numbers that I got back in April. 17:57:46 But I noticed that there's a a line where the county has traditionally charged us for the use of the accounting system software. 17:57:55 And then I noticed that Chris was telling me to put the same
- amount in a different line to pay for software.
- 17:58:02 And then we talked and it turned out it was the same software. So that's 13,000 that I had in 2 different places of the budget so 13,000 is available right now
- 17:58:11 with no adjustment to any revenue projections. So there's 13,000 available. And then I also noticed that for the first time in many years, we're getting some healthy interest income and that was something that hadn't been recorded until May and I could see, oh, you know, there's probably about 20,000 there.
- 17:58:30 So the number that I feel is safe to add to our calculations is 33,443 and
- 17:58:38 There are 2 recommendations that I would really like to change because of things I've learned subsequent to your meeting last week. 17:58:48 Those were, first of all, the first one is that Don Moyer Boys and Girls Club Youth and Family Services Program, they told us they didn't have other funding for the first time in a few years and would be seeking it, so that lower amount was based on like the cost of staff 17:59:04 turnover and the possibility of them getting additional funding. But that program is really important to families and children in Rantoul, 17:59:14 And so I was thinking, well, we're kind of we're kind of damning them to have to have that turnover cost.
- 17:59:20 So I would prefer, I would like to change my recommendation to full funding for that contract and then I also learned that I was wrong about what Adult Redeploy can pay for
- 17:59:32 so I wanted to change. I think I did change the language for Family Services Counseling and Rosecrance Specialty Courts to seek funding through that because it is not an eligible use of Adult Redeploy Illinois funding.
- 17:59:48 Therefore, there isn't any other funding on the horizon that could be used for the Specialty Courts and the difference between the recommendation the from last week
- 17:59:58 And the amount they requested is Mental Health Court. So I'm also going to recommend full funding for that request so that we can start off Mental Health Court and hope that there does become other funding available for it.
- 18:00:12 Also, so that's what's safe to do within the set of recommendations that you've already talked about for hours and hours and helpfully talked to me about separately.
- 18:00:23 Tomorrow the United Way is going to make a number of funding decisions that could affect some of the programs you're looking at. 18:00:30 And then the County Board will also be making some funding decisions about reallocating ARPA funds that are being returned to them,

- 18:00:38 Partly from us. So as we get these late audits and we figure out how much money is owed back, it goes back to the County and they can reallocate it.
- 18:00:47 So there are 2 things that could happen before we even know about increased revenue projections that might change the picture for some agencies.
- 18:00:57 You know, we've already talked about having, deferring a couple of these recommendations till later or deferring a couple of decisions until later.
- 18:01:06 We might also, you know, just like a little broader sweep, depending on how much money is available, if you want to reconsider allocation awards that you make today.

- The required prior to contract and during the term was to revise financial forms and or consistency and accuracy, consider revising program plan to focus on paid and unpaid caregivers of people who have intellectual developmental disabilities, with and without dementia.
- 18:19:11 And to present it to the CCDBB and MHB for funding through the IDD special initiatives.
- 18:19:18 The recommendation by staff was to not fund through MHB funding due to affordability and defer for consideration
- 18:19:25 for intellectual and developmental disability Special Initiatives funding, pending revisions because the funding is under joint authority of the MHB and DDB board.
- 18:19:35 Approval by both is required. The CCDB approved a motion to defer for later consideration.
- 18:19:43 So I know we wanted to change the wording on this a little. Okay. Bye.
- 18:20:15 Healthy Aging, Improving Family Caregiver MH, deferring for later consideration of funding through the IDD special initiatives fund,
- 18:20:23 with programmatic revisions to focus on IDD and pending approval by. And I will second the motion.
- 18:20:35 Do I do any discussion? Seeing none, can I have a roll call, please?
- 18:20:44 Oh no. So it's a motion to deny. So.
