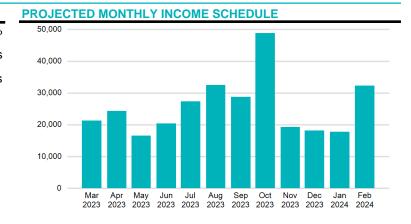

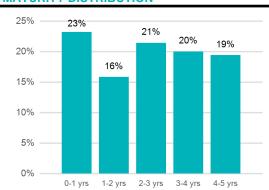


SECTOR ALLOCATION

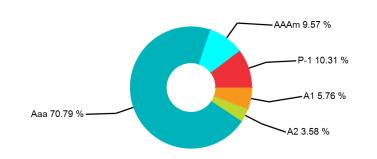
Ending Book Value

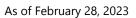

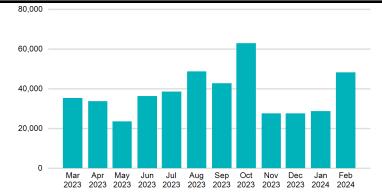

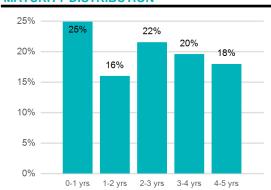
PROJECTED MONTHLY INCOME SCHEDULE



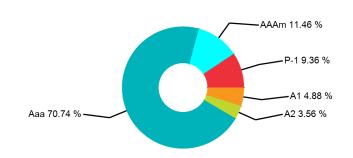
SECTOR ALLOCATION

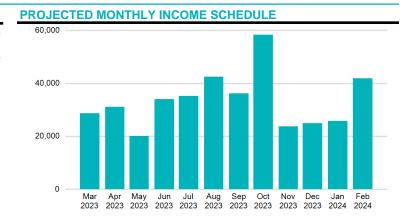

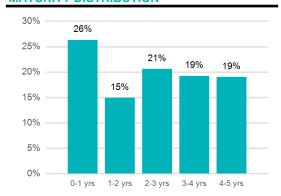

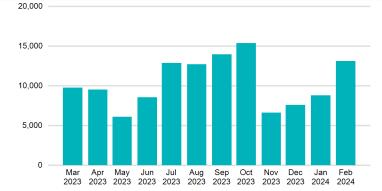

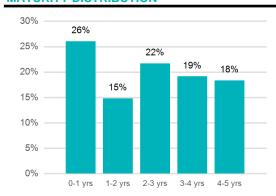
PROJECTED MONTHLY INCOME SCHEDULE 20,000

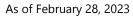
